Ms Natalie Baty, Active Living Programme Co-ordinator, Sport Wellington Region, spoke about *KiwiWalks*, a Hillary Commission Promotion with local Councils, and suggested ways the Regional Council could become involved with the Programme. Ms Baty noted that was the first Regional Council to be approached and there was already one walk in Wellington in Oriental Bay. Copies of walkway signage and leaflets were distributed for information. Truck signage would incorporate the WRC logo. There are minimal cost implications for Regional parks.

Following questions, Councillor Werry said walking was the most popular recreational activity in New Zealand and visitor numbers to Regional Parks suggested this. Councillor Werry thanked Ms Baty for her comments to the Committee.
