Councillor Shields invited the following persons to make oral submissions to the Committee:

- Mayor Iride McCloy and Glenn Innes - Kapiti Coast District Council
- Mayor Jenny Brash and Ms Sue Veart, Porirua

Members noted that Mayor Kirton had been unable to attend and Mr Heerdegen had also sent his apologies.

Councillor Shields suggested that Councillor Armstrong, Wellington City Council, who was present in the public gallery, be invited to speak on behalf of the residents of Tawa.

*That Councillor Armstrong, Wellington City Council, be invited to speak.*

Councillor Armstrong said he was a Wellington City Councillor and was also a member of the Tawa Community Board. He was speaking as a member of the Community Board.

Councillor Armstrong said the local community did not support combining the Tawa Community Board Area with Porirua City and said it should remain in Wellington City.

- *Kapiti Constituency – comprising Kapiti Coast District*
- *Mana Constituency – comprising Porirua City*
- *Wellington Constituency – comprising Wellington City*
- *Lower Hutt Constituency – comprising Lower Hutt City*
- *Upper Hutt Constituency – comprising Upper Hutt City*
- *Wairarapa Constituency – comprising South Wairarapa City Masterton District, Carterton District and part of Tararua District*

**Amendment***(Cr Allen /Cr Thomas)*

*That Porirua City and the Tawa Community Board area be combined into a single constituency.*

The amendment was **Lost** on a show of hands 2 in favour and 8 opposed.

Councillor McQueen noted in moving the following amendment that it was as proposed by Mr Mellor on page 1 of his written objection.

**Amendment***(Cr McQueen /Cr McDavitt)*

*That the Wellington Constituency, comprising Wellington City, be divided into 3 constituencies comprising North-Western, with 2 Councillors, South-Eastern with 2 Councillors and Lambton with 1 Councillor to enable more effective representation.*

- Lower Hutt Constituency – comprising Lower Hutt City
- Upper Hutt Constituency – comprising Upper Hutt City
- Wairarapa Constituency – comprising South Wairarapa District
- Masterton District, Carterton District and part of Tararua District
