It was agreed that officers investigate the viability of the proposed WRC River Ranger using the Fish and Game New Zealand warrant as a means to monitor adverse impacts of vehicles on river ecology and other users of the river environment.

The Committee also strongly endorsed commencing the proposed Hutt River Ranger Service in July 2002.

It was also agreed that through the Environment Committee of the Wellington Regional Council the influence of land management in the upper catchment on the river system downstream be considered.

The Committee also suggested that Councillor Buchanan, Wellington Regional Councillor and Chairperson of the Council's Environment Committee discuss trout fishery and impact issues at a future meeting of the Advisory Committee or the ongoing Management Committee structure once the Management Plan had been approved.
