The Chairperson said members will have received a copy of a Councillors' Bulletin which included recent Dominion newspaper articles and papers about Council's policy for the General Manager to enter into negotiations with Tranz Rail about the future purchase of Tranz Metro

The Chairperson said he strongly disagreed with comments by Councillor Gibson about the General Manager in one of the Dominion articles.

The Chairperson concluded that he had indicated in the Bulletin that he would be raising the matter at today's meeting with a view to seeking a formal resolution distancing Council from Councillor Gibson's comments.

# **Passenger Transport Committee – 1 November**

The Public Excluded Minutes of the meeting are attached. These show the Committee's resolution and attendance at that part of the meeting (the relevant minute has subsequently been made public by Council Resolution on 7 December). There is no record of any dissenting votes.

As is clear from the Transport Committee's Resolution, Council has not yet reached any formal decision to make an investment or at what level. The options discussed were set out in **Mr** Stone's overhead which has been provided to all Councillors and it was clear that he was expected to proceed along the lines of Options 3 and 4.

# **Ouestion 3**

# <u>Answer</u>

In terms of parts 2 and 3 of the Resolution, the matter cannot be **finalised** without Council approval or a legal mandate. The Report following Mr Stone's negotiations will, no doubt, formally discuss the issues you raise.

- 4. Form an alliance with a committed rail operator (other than Tranzrail) and jointly purchase 50/50 the existing operation as a going concern.
- 5. Negotiate rail access agreement with Tranzrail and tender out the operations (the Auckland option)
- 6. Work with Government and other stakeholders to acquire the whole of Tranzrail and break out Wellington passenger operation the remainder to be sold.
