BAY EXPRESS

I am writing to advise that a meeting has been arranged with Mr Don Gibson, Managing Director of West Coast Railway, to discuss the future of the 'Bay Express' tourist train.

The meeting will be held as follows:-

City Council Civic Building, Hastings Street, Napier

As you will see by the attached address list, significant stakeholders such as the Union, regional tourism organisations and significant tourist facility operators have been included, as well as territorial, regional Councils and Members of Parliament along the Bay Express route. The list, of course, is not exhaustive, because it does not include R.T.O.'s, major operators or M.P.'s outside of the Hawkes Bay region.



Accordingly, Mayors or Chairmen of the more southern Councils are invited to involve such parties as they feel appropriate. However, I am conscious that numbers need to be kept to a reasonable size and so it may be appropriate in some instances for one person to represent more than one local authority and/or other stakeholder groups in their geographic region.

Information obtained to date indicates that for the Bay Express operation to be viable, around \$300,000 per annum of extra revenue needs to be generated. That, in my view, should be quite attainable, backed up by promotion and usage encouragement from the $RT.O.\$'s and Councils etc.

In the meantime, I have contacted the Tranz Rail Managing Director, Mr Michael Beard, seeking financial and other information relating to the Bay Express operation which, if they are willing to provide, could be the basis of the building of our business case. Any information I can obtain I will circulate to those organisations who indicate their attendance at the meeting. Likewise, I would appreciate the receipt of any pertinent information held or obtained by others for either prior circulation or discussion at the Strategy Session on the $9^{\rm th}$ July.

I trust that you approve of the **need** for a **lead** to **be** taken urgently in this matter-hence my **co-ordinating** initiative.
