Information obtained to date indicates that for the Bay Express operation to be viable，around $\$ 300,000$ per annum of extra revenue needs to be generated．That，in my view，should be quite attainable，backed up by promotion and usage encouragement from the R．T．O．＇s and Councils etc．

In the meantime，I have contacted the Tranz Rail Managing Director，Mr Michael Beard，seeking financial and other information relating to the Bay Express operation which，if they are willing to provide，could be the basis of the building of our business case．Any information I can obtain I will circulate to those organisations who indicate their attendance at the meeting． Likewise，I would appreciate the receipt of any pertinent information held or obtained by others for either prior circulation or discussion at the Strategy Session on the $9^{\text {th }}$ July．
