- While acknowledging the distinction between governance and technical and management issues, the Committee encouraged officers to continue to work with the Wellington City Council for a smooth transition of the Water Services Agreement.
- If necessary, Councillor McQueen, Chairperson, Utility Services Committee, and Councillor Hutchings, Chairperson, Transport and Infrastructure Committee, Wellington city Council, agreed to meet to discuss the transition process.
- Councillor Hutchings said he had been unaware of the recent difficulties until today's meeting.

Strategy and Asset Group – Hutt, Wainuiomata and Orongorongo Catchments – Consents

Members noted that surface water consents have been granted for extraction from the streams and rivers in Hutt, Wainuiomata and Orongorongo Catchments. This resulted from a process started over two years ago. Mr Benham said today was the final meeting of the Utility Services Committee for the Triennium and he had enjoyed the support, guidance and advice of members during the past three years.

The governance and management perspectives had worked well, and Mr Benham thanked members for the way they had worked as a team during the past three years.

Mr Benham said Councillors McQueen, Macaskill and Shaw were not standing for the Regional Council in the forthcoming elections and said he would first like to thank Councillor Shaw for his very helpful advice as Deputy Chairperson of the Committee.

Mr Benham also paid special tributes to Councillor McQueen and Councillor Macaskill who were not standing in the forthcoming elections. Both Councillors were presented with gifts which were received by acclamation.

Councillor Macaskill was presented with the gift of a mechanical water level indicator, from the 1920's with a clock mounted in place of the dial. He said he would treasure this fascinating piece of craftsmanship. Councillor Macaskill said the history of water distribution in the Wellington region had a special place in his memory. Maintaining confidence and enhancing the supply of water in recent years could not have been completed without the support and leadership of Mr Benham and his great team.

Councillor McQueen was presented with a flow meter from the 1930's with a clock in place of the dial. In thanking the staff of Utility Services Division said he had enjoyed working with Mr Benham and his team during the past six years. Councillor McQueen also thanked members of the Committee for their support and advice and especially thanked Councillor Hutchings for his liaison role from the Wellington City Council.
