## **Divisional Report**

### 1. **Purpose**

- To comment on the Utility Services Division's financial performance for the two months ended 31 October 2001.
- To outline various other relevant areas of interest or activity.

### 2. First Committee Meeting of New Triennium

A warm welcome to new Councillors and those returning. As you will undoubtedly notice from the attached Managers' reports, the activity of this Division is very much operational by nature. While some may consider that we overdo a little the level of detail, we prefer to err on the side of too much information than too little.

The attached Managers' reports also provide a useful formal record of activities throughout each year.

#### 3. Divisional Performance for 4 Months Ended 31 October 2001

#### **Water Supply**

The overall financial results for the first four months of the year are satisfactory with operating costs tracking under last year – and well under budget. While this is early on in the year, and a wet or dry summer will impact on costs – it is pleasing that the trend of the last five years continues.

Capital projects, while under budget, are proceeding satisfactorily and we do not foresee any completion difficulties.

#### Network

This is the area where the contract with Wellington City Council (WCC) is managed. We are comfortable with the financial position to date but much will depend on final payments from WCC.

#### **Plantation Forestry**

Better than expected results were achieved for the first quarter of the year with the early completion of harvesting of the outstanding 2000/01 Pakuratahi blocks. October was a poor month, cash flow wise, as the Pakuratahi harvest was complete and harvesting unable to commence in Puketiro forest because of contractual issues. These were resolved and harvesting has now started.

The October figures include the sale of land and trees to Transit NZ associated with the Kaitoke deviation. This one-off transaction improved the result by \$96,000.

# 3. Update on Water Services Agreement (WSA) with Wellington City Council
