# **Regional Council Input into District Planning**

# 2.3 South Wairarapa District Council

## Notified Consents Herrick A

#### <u>Action</u>

6 lot subdivision, New York Street and SH 53, Martinborough. Attended hearing and presented evidence relating to the contamination of lots 1 and 2 by fill dumped on site and recommending conditions to mitigate these and other concerns (flooding, stormwater and sewage disposal). District Council concerned about contamination and intended to set aside contaminated lots for further consideration. Consent granted, but conditions failed to address contamination issues on lots 1 and 2. WRC have appealed the decision to ensure these issues are addressed. Attended informal mediation and have reached agreement on additional conditions, pending preparation of suitable management plan by applicant. Awaiting finalisation of management plan and conditions for consent order.

Trigg K

3 lot subdivision, Dublin Street, Martinborough. Made a submission noting concealed faultline in the vicinity and recommending new buildings be designed earthquake resistant. Supported connection to urban sewerage system.

Tulloch S

5 lot subdivision, Princess Street, Martinborough. Made a submission noting concealed faultline in the vicinity and recommending new buildings be designed earthquake resistant.

# Non-notified Blackett G

#### Action

Subdivision and boundary adjustment, Te Rata Road, Pirinoa. Made comments on faultline in vicinity and the presence of many Maori heritage sites on the property. Also asked to be consulted if accretion claim along the Turanganui River made in the future.

2 lot subdivision, Cross Creek Road, Featherston. Made comments on effluent disposal.

4 lot subdivision, Greytown Bidwills Cutting Road, Morrisons Bush. Made comments on effluent disposal and proximity to piggery.

Effluent disposal system for relocated dwelling in Lake Ferry. System would not meet Regional Rules. Worked with applicant to come up with alternate system which included separate greywater disposal for which Regional Council consent was granted.

3 lot subdivision, Blue Roack Road, Ruakokopatuna. Noted presence of significant bush remnant on site and recommended protection. Also passed application on to DoC for their comment.

Wilson, K

Landuse consent to construct a dwelling, Cape Palliser Road, Cape Palliser. Application not notified and Regional Council not considered an affected party, comments sought as interested party only. Commented on the effects on the character of the coastal environment, effluent disposal in this location and Regional Council consent requirements for taking water.

3 lot subdivision, Cannock Road, Hinakura. No comments necessary.

Johnson F

2 lot subdivision, Battersea Road, Greytown. No comments necessary.
