Mr Horne said that the Regional Land Transport Strategy, which was prepared in 1999, needed substantial revision to make it relevant to the new century and the new millennium.

Mr Horne gave reasons why the Strategy was out of date and suggested that the Regional Council should invite Dr Morgan Williams, Parliamentary Commissioner for the Environment, to speak about his recent visit to Brazil and especially the public transport system which operated very successfully in Curitiba, Brazil.

A copy of Mr Horne's representations were circulated.

Councillor McDavitt said that Dr Williams had given a paper to the Regional Council earlier this year and suggested that territorial authorities and the Regional Council would do well to invite Dr Williams to speak again in the future.

A. The Wellington Regional Land Transport Committee recommends to Wellington Regional Council that:

- (1) It adopts, as an integral part of its thrust for sustainable development, and in conjunction with the territorial local authorities a campaign to alert residents within the region to the environmental consequences of vehicle use, with particular reference to traffic congestion, growth in vehicle numbers and vehicle efficiency.**
- (2) That as components of this strategy it recommends to the Wellington Regional Council to consider in its coming Long Term Financial Strategy -**
 - Firstly seeking to co-ordinate and carry out, with the territorial local authorities taking the primary role, an 0800 SMOKEY campaign.**

Other Matters

RLT 30 Questions

Paekakariki Crossing

Councillor Brown raised concerns about the speed of traffic on State Highway 1 adjacent to Paekakariki and it was noted that a local variation process was under consideration.

State Highway 1 Upgrade near Plimmerton

Mr Efford expressed concern that an overhead pedestrian crossing should be maintained near the Plimmerton Railway Station. This matter was under consideration.

Peka Peka Road

Mr Royds said the concerns about the Highway near Peka Peka were gaining momentum and therefore proposals should appear higher in the priority list. Mr Hunter said that investigations were underway.

Letter from Manukau City Council re Land Transport (Street and Illegal Drag Racing) Amendment Bill

Councillor McDavitt said this was a matter for territorial authorities and there was no need for involvement by the Regional Land Transport Committee unless requested by the territorial authorities.

2001/2002 State Highway Review

Mr Brennand said he had received a letter dated 20 May 2002 from Transit New Zealand requesting comment from the perspective of the Regional Land Transport Strategy. Mr Brennand said the list was not inconsistent with the Strategy and the Regional Council proposed to advise Transit New Zealand of previous discussions.

RLT 31 General

Mr Brennand referred to a letter from Transfund New Zealand dated 22 May 2002 to the Chairperson, Wellington Regional Council, concerning Transfund's funding allocation framework. A copy would be circulated in an Appointees Bulletin. The matter had been covered earlier in the meeting and action was proposed by the Advocacy Strategy Subcommittee.

Paraparaumu Park and Ride Facilities

Mr Barnard expressed concern about the need for expansion of Park and Ride facilities near Paraparaumu Railway Station.

Councillor McDavitt said Park and Ride issues were constantly under review in the Passenger Transport Committee.
