## **HRA 14** June Flooding

Mr Murphy, Operations Engineer, said the recent flooding on the Hutt River had been a 5 year event. The structural and non-structural measures stood up well and no significant damage had occurred. Mayor Terris said the Hutt City Council was in the process of installing a number of stormwater improvements and if the downpour had occurred several weeks later the work would have been completed and the flooding at Melling would not have occurred.

Members noted that an amazing array of waste found its way down stormwater drains and the consequent blockages cause a lot of flood damage.

While the Hutt City Council carries out regular maintenance the public should continue to be discouraged from placing rubbish in stormwater drains.

Homeowners can provide positive assistance by regularly clearing leaves and other debris surrounding gutter sumps on and near their properties.
