Councillor Thomas said the recent special edition of Elements appeared to contain an implication the Regional Council was extending its core business to extra responsibilities and asked to what extent Councillors had been involved in the planning of the publication?

Councillor Kirton also asked why the recent edition of Elements implied the Regional Council was taking on extra responsibilities.

Councillor Turver questioned the way the material had been presented in the recent Elements with the implication that the Regional Council was moving into areas outside its preserve and asked why Councillors had not been consulted before Elements had gone to press.

Councillor Evans asked why Elements had not carried a defined vision statement showing the Regional Council's part responsibility within that vision.

Councillor Laidlaw asked whether officers were also consulting with territorial authorities in parallel with the Elements consultation.

Mr Allard said that, as had been noted when the Council had approved the consultation process using Elements at its August 6 meeting, due to time constraints it had not been possible to consult with Councillors about the detailed content before publication but the material in Elements portrayed a summary of recent discussions with Councillors.

Mr Allard said that given the proposed new legislation the present community discussion must be broad based especially as the Regional Council itself had not yet reached any view on its own direction for the next 10 years.

Mr Allard concluded the subject will be debated by Council between now and the end of November. Elements was the start of a long consultation process to determine the Regional Council's future direction.

Mr Allard said high level discussions were also taking place with the territorial authorities and these were progressing in a relaxed and cooperative way.

Responding to Councillor Barr, Mr Allard said enquiries and comments should be forwarded for inclusion in a summary document. Councillors will be forwarded a copy of the summary for their 21 October workshop.
