3. Comment

At the end of August the Division overall was \$39,000 over budget with revenue being \$268,000 below budget and operating expenditure \$229,000 below budget. Capital expenditure at August was \$98,000 below budget.

Significant components of this unfavourable variance are as follows:

(1) Biosecurity Department \$50,000 Unfavourable

The net position for the Bovine Tb activity was \$58,000 below budget due to the timing of control operations. Pest Animals and Plants had timing savings for contractors, but this is partly offset by additional net expenditure in Department Admin (reduced transport recoveries and gain on sale of vehicles).

(2) Operations Department \$28,000 Unfavourable

External revenue was \$52,000 below budget due the timing of Soil Conservation works, Reserve Forests logging revenue, and River Scheme District Council contributions.

(3) Support Services Department \$25,000 favourable

The variance related to timing savings for materials and the Opaki and Fernridge Water Supply Scheme payments.
