### **Draft Consultation Document**

Councillor Brown arrived at 10.00am.

Members then discussed the preliminary draft consultation brochure as follows:

- The link with economic growth and urban growth strategies should be more explicit.
- The Silverstream bridge should also include a reference to Hutt City Council as well as Transit and Upper Hutt City Council.
- The industrial area should be identified in the map
- The State Highway 2 Petone to Ngauranga Options should include a more explicit statement concerning options and downstream effects beyond Ngauranga Gorge.
- Extend the discussion of cycling lane options on the Hutt Road.
- Finetune the references to and relationships between the access west and across the valley floor and update the views of the technical group.
- Downgrade the Petone-Grenada link from the one "recommended" option and include more discussion on the Melling –Porirua link as another option.
- Add 4-laning of SH58 to TG alignment as an accepted new project.

- Include the new bus initiatives within the paragraphs for bus versus rail.
- Upgrade the Hutt Corridor Plan map.
- Update the timetable to reflect the adjustments from today's meeting.
- Revise the diagram on page 6.
