# RLT 50 **Public Participation** (contd)

## **Daryl Cockburn**

Mr Cockburn said that having cycled to the meeting from Woodside Railway Station, after travelling by train from Wellington he wished to say that cycling and the other modes which do not create hazards to other road users are the modes to promote. These are the only modes to be promoted.

Mr Cockburn then suggested ways that cycling could be encouraged and emphasised the preventative health aspects of daily exercise by cycling.

Mr Cockburn said suburban sprawl and road building are the main causes of car dependency and the truth is that the territorial authorities have not been able to resist pressures for suburban sprawl and car use.

For example proper professional surveys showed there are other much more pressing demands for the scarce resources than improvements on the Hill Road.

A copy of Mr Cockburn's representations were circulated.

# Mr J C Horne, 28 Kaihuia Street, Northland, Wellington

Mr Horne addressed the following issues:

- Why did not members travel to today's meeting in Greytown by public transport?
- The Committee should promote ways to improve the train services to the Wairarapa and not spend money on improving the Rimutaka Hill road route.
- The Hutt Corridor Plan Subcommittee should have a representative from public transport users/cyclists/pedestrians.
- Government should introduce more serious penalties for traffic growth pollution in Wellington and the consequent health effects.
