PT 75 **Public Participation**

Kathleen Johnson, Titahi Bay and Ivan Jones, Pak N Save Porirua

Kathleen Johnson said she had organised a petition containing 579 signatures which had been sent to the Wellington Regional Council seeking an extension of the City Link bus service to include the Pak N Save Supermarket on Parumoana Street, Porirua on its regular scheduled service.

Such a bus service would add to the safety of the pedestrian citizens and ratepayers of Porirua in the greater Wellington area.

Mr Jones, Owner Operator Porirua Pak N Save, said that he would co-operate with the Regional Council to ensure a bus stop was established in a safe area probably using a part of the existing parking facilities in the Pak N Save complex.

Councillor Turver said the petition had been tabled at today's meeting. The Regional Council would formally respond to the petition and invited Mr Cross to give an initial comment.

Mr Cross explained some of the issues to be taken into consideration when considering a change to an existing bus route. Progress was being made to facilitate a bus stop at Pak N Save as soon as possible within existing contractual negotiations.

A copy of the written submission was circulated.

Mr Horne spoke to Item 5 on today's agenda concerning Regional Land Transport Committee matters.

Mr Horne also spoke about the Hutt Corridor Plan and its implications for passenger transport and confirmed he would be making a submission on the Plan.

Mr Horne concluded with some general comments including suggestions for improving public transport services in the region.
