## **US 71 Public Participation**

## Mr Huckstepp

Mr Huckstepp said that he had a simple proposal without ambiguity to paint a smiley face on the top surface of Greater Wellington's Ngauranga Reservoir. If the Regional Council supported the proposal in principle the Wellington region will then have an opportunity to voice an opinion on the proposal through a resource consent process.

#### Mr Walker

Mr Walker said a smiley face on the Ngauranga Reservoir would have an adverse effect on the quality of life for people living near the area. There were no economic benefits or cultural advantages and the smiley face would only be seen from the air by 1.7% of travellers in and out of Wellington airport.

## Mr Wright

Mr Wright said he was a resident of Broadmeadows since 1974. He had a wonderful panoramic view and until now authorities had done everything possible to disguise the presence of the Ngauranga reservoir. Mr Wright produced photos for viewing by members. Mr Wright said the concrete on the reservoir had weathered and the colouring now blended in with the environment on the hillsides. Mr Wright noted that of those residents who can see the reservoir from their properties, 26 opposed and 9 supported the smiley face.

- A letter dated 18 March 2003 to Mr Walker from Mr Samuel, Greater Wellington Water

# US 73 Smiley Face Mural Consultation – Result and Further Requirements

That Greater Wellington's further support for painting the proposed mural on Ngauranga Reservoir be declined, in light of the survey results and Wellington City Council's viewpoint.

The above motion was **LOST**, three votes in favour and five opposed.

That the Committee:

- (1) Notes that resource consent approval is now required, under Wellington City Council's District Plan, before the proposed Smiley Face mural could be painted on Ngauranga Reservoir.
- (2) Notes that Wellington City Council does not support the proposed mural being painted on Ngauranga Reservoir.
- (3) Notes the results of the Greater Wellington-run survey of opinion about the proposal, conducted in the Broadmeadows area, be noted.

Reaffirms Greater Wellington's support for the proposed mural, subject to the proposer gaining the appropriate resource consent from Wellington City Council, be reaffirmed.

The above motion was **LOST**, 4 votes in favour and 4 votes opposed on the casting vote of the Chairperson.

When voting had been completed on the above item Councillor Thomas asked about the status of Councillor McDavitt when he attended meetings of the Utility Services Committee both as a member of the Committee and Deputy Chairperson of Council.

Mr Darroch said the Council Chairperson and the Council Deputy Chairperson are not members of the Utility Services Committee when considering Wellington Bulk Water Supply matters. Also the Deputy Council Chairperson does not vote when the Council Chairperson is present.

Following discussion the meeting agreed to proceed to the next item of business.
