Report of the Meeting of the Passenger Transport Committee held in the Wellington Regional Council Chamber, The Regional Council Centre, 142 Wakefield Street, Wellington on Thursday, 24 April 2003 at 9.30am

Procedural Items

PT 94 **Apologies**

Resolved

(Cr Turver/Cr McDavitt)

That the apologies from Councillors Buchanan, Kirton and Yardley be confirmed.

PT 95 **Public Participation**

Mr Tony Randle – Bus and Rail Commuter, Johnsonville

Tony Randle discussed the possibility of Council replacing trains with buses. He expressed his concern with the Council's lack of strategy for buses as a main commuter system to the north of Wellington City, especially for the Johnsonville area. He also urged Greater Wellington to look at a rapid transit strategy that is focussed on transport corridors, rather than the mode of transport.

Tony Randle argued that if a good road corridor was established, buses may well become more viable than trains, providing faster travel times for commuters. While there are advantages to rail transport and it can be better for high volume, long-haul trips, Johnsonville is a short-haul trip that may lend itself to buses.

Mr Brent Efford – Chair of Transport 2000+

Brent Efford expressed his support for the continued use and upgrade of trolley buses in Wellington's central business district. He noted that trolley buses are a local sufficiency enterprise as the energy, labour and the parts required to run them are all supplied locally. Trolley buses are also a better alternative to diesel buses, as they do not produce noise and air pollution.

Brent Efford also stated that it was high time for Greater Wellington to start a comprehensive rail development strategy. He believes that a light rail system to Courtenay Place would be completely practical and may even attract too much patronage.

PT 96 **Confirmation of Minutes**

Committee members requested that the numbering of the minutes be amended from *PT 87 Hutt Valley Bus Service Review* to read *PT 88 Hutt Valley Bus Review*.

PT 97 **New Staff in Transport Division**

Dr Watson introduced the new staff members in the Transport Division: Rhona Nicol, Kelly Maher, Karen O'Reilly, Lesley McConnell and Gunther Wild.

Matters for Decision

PT 98 Patronage Income and Operator Contract Payments

Dr Watson added that the Tranz Metro Wellington's patronage figures for March were up slightly (0.33% or 3,000 commuters) from February. He noted, however, that this figure did not include Easter, whereas the figures for the same time last year did.

Over the last three months patronage on Tranz Metro trains has decreased by 74,000. It was initially predicted that there would be a 2% growth over this period. Dr Watson advised that it is, therefore, necessary to consider the Council's contract with passenger transport operators.

There was general agreement with the need to put a clause in the contract to provide a disincentive for "poor performance". However, some committee members expressed concern over how "poor performance" could be quantified and qualified. It was discussed that this could be specified by the criteria of the contract.

- (2) *That, in principle, all future operator contracts with passenger transport operators include a clause to allow the Council to reduce any contract payments to the operator, being an amount equal to the loss in the Council's patronage income resulting from, in the sole view of the Council, an operator's poor performance. The criteria for poor performance would need to be specified in any such contracts.*
- (3) *That the Committee be provided with a legal opinion on key issues associated with this proposed policy.*
- (4) *That the matters discussed be reported back to the next Passenger Transport Committee meeting.*

- (5) *That, with respect to the current Tranz Rail Limited contract, the Council will pay the operator on receipt of monthly patronage data related to the monthly contract payment.*

Councillor Kirton voted against resolution (5).

PT 99 **Trolley Bus Services Beyond 2004**

Dr Watson clarified that Council is able to start negotiations with Stagecoach for a trolley bus service, without going through an open tender process, because the Competitive Pricing Process outlined by Transfund provides for negotiation with one operator where the company is the sole supplier.
