**Mr Robin Maud, Convenor, Rotary River Trail Committee**

Councillor Laidlaw said that with leave of members he would like to ask Mr Jackson, Advisor Community Projects to introduce Mr Robin Maud of Hutt Rotary who wished to speak.

Mr Jackson said the Regional Council had been involved with Community Groups in a number of projects such as wetland, riparian and replanting restorations at various locations in the region including Queen Elizabeth Park, a totara grove at Te Marua, and the Hutt River Trail. Mr Maud has led the involvement of Hutt Rotary and other Rotary Clubs in the Hutt Valley in a number of co-operative ventures with the Regional Council. Mr Jackson then invited Mr Maud to speak.

Mr Maud in thanking members for the opportunity to speak, said that the Hutt Rotary Club had been involved in community projects for the past ten years. He was pleased that Hutt and other Rotary Clubs in the Hutt Valley were now involved with the Regional Council in projects such as the promotion of the Hutt River Trail. There were plans to extend the trail through Upper Hutt, over the Rimutakas and into the Wairarapa.

Mr Maud said the River Trail Committee had recently assisted with the completion of a walkway under the Waione Street Bridge on the Eastern side of the Hutt River near Seaview. This involved the building of a wooden walkway cantilevered out over the river and attached to the road bridge. This walkway had cost \$30,000 and had been jointly funded by Greater Wellington, the Hutt Rotary Clubs and Hutt City Council. Mr Maud said the teamwork had been really good and will continue with the development of the river trail walkway beyond Upper Hutt and into the Wairarapa.

Mr Maud said that as the trail improves the numbers using the walkway continues to increase each day of the week.

Councillor Laidlaw thanked Mr Maud for the very constructive collaboration now taking place in the Hutt Valley between Rotary Clubs, the Hutt City and Upper Hutt City Councils and the Regional Council.
