Foreshore and Seabed

Councillor Evans said that although the Government had not yet announced the proposed new Foreshore and Seabed policy there will be significant consequences for Regional Councils including Greater Wellington. There were also important jurisdictional issues to be resolved between the High Court and the Maori Land Court.

It was noted that Greater Wellington had supported the LGNZ submission which affirmed community access to the seabed and foreshore and community rights. It was agreed the officers keep a watching brief on any Government initiatives and report to Council when the new policy is announced.

Standing Orders

Councillor Thomas said it would be useful for Councillors to have a better understanding of Standing Orders.

Dr Hastie said while a new set of Model Standing Orders had been published a further revision was now underway to include the provisions of the new Local Government Act 2003. Dr Hastie said he will follow up Councillor Thomas' suggestion once the current review had been completed.
