The Chairperson advised that Mr Joe Taylor wished to speak on the matter of increased numbers of Canadian Geese previously raised at the September Committee meeting. Mr Taylor said that Wellington Acclimatisation Society notes from 1979 had indicated that the Society had accepted full responsibility for the control of Canadian Geese in the Wairarapa and the rest of the Wellington district.

Members had noted that Canadian Geese were not classified as a pest within the Regional Pest Management Strategy and their control came under the jurisdiction of the management agencies Fish and Game, and the Department of Conservation.
