# Kaitoke Regional Park Management Plan Review

### 1. Purpose

To consider submissions on the draft Kaitoke Regional Park Management Plan and seek approval to prepare the final management plan for consideration at the next Landcare Committee meeting.

### 2. Significance

The matters in this report do not trigger the Council's significance policy or section 76(3)(b) of the Local Government Act 2002.

# 3. Background

The Kaitoke Regional Park Management Plan review began last year. During the first round of consultation, ten submissions were received on the park and its existing management plan. The Committee considered these submissions in July last year (report 04.425). A draft plan was prepared taking into account those submissions, the *Regional Parks Network Plan* and policy direction from the Committee. The draft plan was released for consultation in October last year and submissions were invited until 31 December 2004.

### 4. Submissions

A total of 9 submissions were received on the draft plan. Submissions and a summary are attached for your consideration (Attachments 1 and 2).

JC Horne and B Mitcalfe would like to be heard in support of their submissions and will be presenting their submissions in the public participation part of this Landcare meeting (Submission 7, Wellington Botanical Society, and Submission 8, JC Horne and B Mitcalfe).

#### 5. Key issues

Generally submitters were supportive of the management plan's approach and content. A table is provided on the following page summarising the issues raised by submitters, officer's comments and a recommended response. Some small editing changes are also required.

## 6. Iwi

Contact with the Wellington Tenths Trust and Te Runanganui o Taranaki Whänui ki te Upoko o te Ika a Maui was maintained throughout the review process. No submissions were received from Iwi, although Iwi representatives have indicated that they are happy with the approach taken in the plan.

# 7. Water Supply Assets

The Te Marua pumping station and Stuart Macaskill Lakes are contained within Kaitoke Regional Park. These areas are excluded from the plan's management zones (p8, draft management plan) but may be affected by future park developments.

In 2002, a design was prepared in consultation with the Utility Services Division for landscaping around Te Marua Lakes (report 02.594, Attachment 3). The design was incorporated into the potential development plans in the draft plan. No submissions were received on these designs.

To ensure the management plan clearly reflects that these water supply assets will not be not adversely affected by any future park development, Officers recommend that a policy be inserted within the 'Park development' section that states:

To ensure that any development recognises the regional importance of the water supply functions of the Te Marua pump station and Stuart Macaskill Lakes.

### 8. Next steps

The next phase of the plan review process, after the committee has considered the submissions, is to draft the final plan. A workshop will then be held with Councillors to discuss the draft of the final plan on 16 February 2005.

# 9. Communication

A letter will be sent to all submitters, outlining the results of the Committee's deliberations. A newsletter will also be prepared and sent to all those people that have signalled an interest in the park and/or the review to date. Once the Committee is satisfied with the final plan, copies will be made available to stakeholders, submitters, Council offices and libraries. The management plan's adoption will be announced with a media release and will be included in the next Green Shoots community newsletter.

#### 10. Recommendations

That the Committee:

- 1. receive the report and note the contents of the report.
- 2. consider the attached submissions on the Kaitoke Regional Park Draft Management Plan
- 3. *approve* Officers to finalise the drafting of the Kaitoke Regional Park Management Plan for consideration incorporating the changes highlighted within this report at the next Landcare Committee meeting
