This would ideally be prior to the first Ara Tahi meeting for 2006 to allow Ara Tahi to finalise their proposed Iwi Commissioners to Greater Wellington for consideration at the 1 February 2006 meeting.

Following this workshop, the next topic for consideration could be the finalised State of the Environment Report. The information in this report is very important and makes sobering reading. However we are interested in your views as to whether a technical workshop is the most appropriate forum to discuss this.
