Proposed improvements to Wellington's passenger transport: train network. Paula Warren.

Paula Warren and Michael Nicholson

Ms Warren suggested improvements to Wellington's passenger train network, and expressed concern that the present perceived inadequate infrastructure may encourage commuters to return to using cars. She urged the purchase of more rolling stock, and greater use of off-peak services.

Mr Nicholson, a Tranz Metro engine driver, described problems with the rail infrastructure in the Wellington region encountered from personal experience. He feels that the rail infrastructure has reached a crisis point created by old equipment, and the need for more double-tracking.

Stephen Knight (CycleAware Wellington)

Mr Knight urged the Committee to support a significant increase in the cycle-carrying capacity of new rolling stock. He maintains that cyclists are increasingly using rail as part of longer composite journeys. Mr Knight felt that extra capacity will both facilitate this and encourage cycling as a mode of transport.

Michael Gee (Rail Heritage)

Mr Gee urged the Committee to support the restoration of several English Electric EMUs for use as a tourist attraction for special excursions and/or at low traffic volume periods.
