A petition comprising 3777 signatures collected by the Kapiti Transport Action Group was accepted by the Committee. The petition asks GWRC to:

- Welcome the 8.6% increase in passenger volumes, which reduces road congestion and shows strong support for public transport.
- Reject options which reduce our rail service, including increasing the proportion of standing passengers..
- Find the necessary funding or seek additional Government funding to increase the capacity of the region's trains to match demand now..

**Lindy McIntyre, Alan Tristram, and Mike Woods** presented the above petition on behalf of Kapiti Transport Action Group and spoke to it.

The group maintained that the current increase in use of public transport could have been predicted. It complained that trains are too often overcrowded and late, Tranz Metro is communicating poorly about delays, and that fares have increased.

KTAG opposes the removal of seats to make more room for standing passengers, and encourages the refurbishment of old carriages. It urges GW to seek more funding from Central Government, and not to spend money on "charm offensives", or tell ratepayers there is no money to spend on improvements.

The group feels that there needs to be a shift towards public transport, and that the effects of future climate change should be taken into account. It urged GW to plan on 50-year scale.

**Sue Kedgley** (on behalf of the NZ Green Party) expressed disappointment in the North Wellington Public Transport Study, and urged GW to challenge the assumptions made. Ms Kedgely urges investment in rail and retaining the Johnsonville line. She opposes the removal of seats to make more room for standing passengers, and encourages the refurbishment of old carriages.

**John Collyns** (on behalf of the Bus and Coach Association) favours the Johnsonville bus corridor concept. He feels that the proposal is affordable, and would offer a seamless, one-way service. Mr Collyns maintains that bus transport is more flexible and fuel efficient than rail, and that technological change is more rapid.

**Dennis Foot** regards the North Wellington Public Transport Study to be a “hijack attempt by an anti-rail group” which doesn’t take global warming into account. He feels that a one-way bus system is a retrograde step, as buses use fossil fuel. Mr Foot encourages the retention of the Johnsonville line, and the refurbishment of old carriages.

**John Vannisselroy** (on behalf of the Rail and Maritime Transport Union) expressed disappointment that GW Officers had not consulted with his group on costings of procuring used carriages from Japan. He predicts that removal of seats from carriages would be unpopular. Also, Tranz Metro has a safety policy which restricts train operations when the standing:seated passenger ratio exceeds 1:1. Mr Vannisselroy regards the North Wellington Public Transport Study, as flawed. His group prefers a heavy rail system serviced by small feeder buses.

**David Butler** discussed future growth of the suburban rail system beyond Waikanae, and raised the possibility of a new station north of that point. He feels that the North Wellington Public Transport analysis is totally flawed, and that there is no place for guided bus and light rail.

**Brent Efford** (on behalf of Transport +2000) feels that the North Wellington Public Transport Study has been a “13% sideshow”, and that the technical evaluation report is poorly informed on light rail. He feels that there must be a change in mode share in electric train usage.

**Tony Randle** congratulated GW on its open policy on information sharing. He feels that the report on North Wellington Public Transport Study is seriously flawed, and that the model is “bizarre”. Mr Randle maintains that the ER1 and ER2 rail options have been edited out, and risk has only been built into the busway option. He feels that Central Government influence has been negative.
