**Kerry Waddell**

Ms Waddell, Managing Director of Mana Coach Services made an oral presentation re Student Identity cards. Ms Waddell made the following points:

- Bus drivers have perennial problems with students, who are always trying to obtain concessions. Schools are reluctant to issue IDs, and some tertiary students are still travelling on school IDs. The fact that schoolchildren are out of uniform for 13 weeks adds to the problem.
- There are also problems with senior citizens, who defraud the company as much as schoolchildren. Drivers are reluctant to ask people's age.
- Continual disputes with passengers over concessions slow down the boarding of buses.
- Suggests a standard photo ID for everyone. The onus would be on the individual to obtain IDs, and it would make bus drivers' jobs easier.

Graeme Mowday, Rail Passenger Marketing Manager, Tranz Metro agreed with Ms Waddell's comments.
