*Proposed Draft Wellington Regional Land Transport Strategy.* Letter to the RLTC Chairman from Brent Keith on behalf of the Infrastructure Working Group of the Rail and Maritime Transport Union.

**Chris Horne** felt that the draft of the RLTS fails to plan for the urgent need to cut greenhouse gases from transport, or for the impacts of increasing fuel prices. He recommended that the final draft of 19/10/2006 be withdrawn, revised, then presented to the RLTC before being published for public comment.

Mr Horne recommended that the committee directs Transit NZ to abandon the Transmission Gully motorway project.

**Brent Keith** requested that the Committee amends the RLTS, before it is released for public discussion, to incorporate the following rail infrastructure projects:

- Additional track between Wellington junction and Wellington Station to eliminate the “Kaiwharawhara throat”.
- Double-tracking between Pukerua Bay and Paekakariki.
- Double-tracking between Trentham and Upper Hutt.
- Modification of the Melling junction.

Mr Keith also requested that financial provision be made for projects to relieve other “pinch points” be initiated as required, where timetable reliability issues arise.

**Paula Warren** discussed legal issues relating to the Western Corridor plan. She requested that in the next stage of the RLTS, the full document be open for public submission. Ms Warren was assured by the Chair that this would be done.
