4. <u>WAIWHETU STREAM FLOODPLAIN MANAGEMENT STUDY:</u> <u>APPLICATION TO CONTAMINATED SITES REMEDIATION</u> <u>FUND AND NEXT STEPS</u> (X/23/5/13/RM50-15-11)

Report No. WSAC2006/6/1 by the Project Manager – circulated pages R/7 - R/9.

The Project Manager spoke to his report. He advised that they had lodged an application with the Ministry for the Environment's Contaminated States Remediation Fund for \$5.9 Million and were currently awaiting results.

The Biodiversity Co-ordinator tabled an updated version of Section 2 of the Appendix. He advised that he had made adjustments to the Executive Summary and also in particular to the description of the contaminants which was to highlight the significance of the contamination in his report. He stated that there is no indication from the MfE about the time they will need to process the application.

In response to questions by the Committee, Mr Porteous advised that there is in fact ongoing contamination of the food chain and an investigation was undertaken with MfE using eels and shellfish which showed these results.

The Committee congratulated Council Officers and Consultants on the quality of the report and expedition.

5. <u>WAIWHETU STREAM FLOODPLAIN MANAGEMENT STUDY: 6</u> <u>AND 10 YEAR STAGING OPTIONS</u> (N/03/21/01/RM50-15-11)

Report No. WSAC2006/6/2 by the Project Manager – circulated pages R/10 - R/12.

Project Manager spoke to his report. He in particular referred the Committee to the Recommendation (iii) in his report:

"that staging within a 6 year timeframe is not considered feasible when uncertainties associated with achieving resource consents, final design and resolving property easement issues to secure the floodway are taken into account."

The Chair advised that he believed that the 10 year time frame was more achievable.

The suggestion was made that a couple of workshops be held to discuss prioritisation of work.

Members on the Committee made the following comments:

- The Awamutu works could start immediately as it is Hutt City Council who is to meet the full cost of this project.
- There is a need to know how it is going to impact on Hutt City ratepayers. Financial modelling will be undertaken to this effect.
- Any Council can only commit itself only under the current LTCCP.
- That they agree in principle to 10 years however there be flexibility in programme elements, ordering and timing as this is a work in progress.
- Inflation needed to be taken into account with regards to project expenditure.

Mayor Ogden commented that the workshops would be a good idea regarding prioritising work and that the Awamutu is within HCC's control and decision making.

In discussion it was agreed that an additional clause be added to the recommendations contained in the report, to read:

"Agrees in principle to a ten year timeframe but there needs to be flexibility in programme elements, ordering and timing".

- *(iv) agrees in principle to a ten year timeframe but there needs to be flexibility in programme elements, ordering and timing; and*
- (v) notes that, following completion of the instream works, there is flexibility in the way that the balance of the flood protection works can be scheduled."

Report No. WSAC2006/6/3 by the Project Manager – circulated pages R/13 - R/18.

Project Manager spoke to his report and introduced Ms Karen Muldowney who is the new Project Consultant Manager. Ms Muldowney updated the Committee on the progress since the last WSAC meeting which was held on 7 September 2006,

The Committee agreed that a thank you card and a token of gesture be sent to Ms J Lindesay to acknowledge all of her hard work.

The Project Manager thanked Committee members who attended the public meeting at Gracefield School on Saturday 7 October 2006 and in particular Mayor Ogden who opened the meeting.

The Biodiversity Co-ordinator, commented that legal advice is currently being sought to ascertain Greater Wellington's options for delegating or transferring regulatory powers to Hutt City Council officers for the enforcement of SW discharges. This will be reported back on at the next Waiwhetu Stream Advisory Committee meeting.
