Chairman's Report

Reviewing the past six weeks' activity in preparing this report I realised that no major issues, other than the implications of the 2007 budget, required specific reporting to Council. All of our internal matters, such as the final preparation of the 2007/08 Annual Plan, RPS development and the like are covered elsewhere. However, in looking at my programme as Chairman for this period, I seemed to have been reasonably busy outside of the formal business of Greater Wellington. The list of attendances and meetings set out below gives a sense of this.

1. 2007 Budget implications and "Next Steps"

Of primary interest to Greater Wellington was the announcement of the new provisions for the Regional Fuel Tax (RFT) and budget provision of \$600M for Auckland and Wellington passenger rail networks. All information on these two matters has been publicly available from Central Government and has been reported extensively in the media. No further information is yet available on the details of how the RFT is to be applied, or the allocation of the \$600M rail money. Our officers are working with Central Government officials on this and also on the detail of the "Next Steps" announcements regarding future transport structures and planning. I can't add any further insight on these issues at present, and details will be reported through the transport committees as they are available.
