**WRPT 22 Recommended Passenger Transport Plan and Passenger Transport Operational Plan**

1. *Receives the report.*
2. *Notes the content of the report.*
3. *Notes the changes made to the Passenger Transport Plan following the Subcommittee meeting held on 20 June 2007, and further changes made during the course of this meeting.*
4. *Notes the Passenger Transport Plan has been developed to be consistent with, and to give effect to, the Regional Land Transport Strategy.*
5. *Agrees to recommend to the Passenger Transport Committee the approval of the Passenger Transport Plan as set out in Attachment 1, incorporating changes made by the Subcommittee.*
6. *Requests the Passenger Transport Committee to favourably consider adopting the following resolution:*

*“The Passenger Transport Committee recommends to Council, that it resolves to:*

- a) *Adopt the Passenger Transport Plan as approved by the Passenger Transport Committee.*
- b) *In adopting that Plan, Council believes it is consistent with, and gives effect to, the Regional Land Transport Strategy.*

- c) *Records that the Council intends that future renewals or variations of either or both of the Regional Land Transport Strategy or the Passenger Transport Plan should endeavour to ensure that the documents are consistent with one another, and that the Passenger Transport Plan gives effect to the Strategy (as then existing or approved).*
- d) *That to promote a continuing harmony between the Regional Land Transport Strategy and the Passenger Transport Plan, any proposed renewal or variation of either shall, before consideration by Council, be considered by both the Regional Land Transport Committee and the Passenger Transport Committee, respectively, for their recommendation to Council”.*
7. *Agrees to recommend to the Passenger Transport Committee that the recommended Passenger Transport Operational Plan and any subsequent amendment should first be approved by the Committee then adopted by the Council before formally coming into operation, so as to ensure that the Operational Plan adheres to the vision, objectives, and policies of the Passenger Transport Plan.*
8. *Agrees to recommend to the Passenger Transport Committee, for its approval and recommendation to the Council for adoption, the recommended Passenger Transport Operational Plan as set out in Attachment 2, noting that this is a separate, non-statutory document providing detailed solutions, guidelines, and targets, and is in the course of further development.*
9. *Recommends that the Chairman of the Subcommittee be authorised to approve editorial amendments to the proposed Passenger Transport Plan and the proposed Passenger Transport Operational Plan, and to give final approval to the Subcommittee’s report to the Passenger Transport Committee.*
