Reason for passing this Ground under section 48(1) for the General subject of each matter resolution in relation to each passing of this resolution to be considered:

To seek the Utility Services Committee endorsement to proceed with the land disposal for the purpose an exchange of land.

The information contained in this report relates to Greater Wellington entering into a Memorandum of Agreement with Transit NZ for the disposal of Council land and acquirement of Transit NZ of a public work land in compensation. The on the basis of Memorandum of Agreement has not yet been entered into. The report outlines terms of the proposed which may still be negotiated. Having this part of the meeting open to the public would disadvantage the Council if further negotiations were to take place. The Council has not been able to identify a public interest favouring disclosure of this information particular in public proceedings of the meeting that would override this prejudice.

That the public conduct of the whole or the relevant part of the proceedings of the meeting would be likely to result in the disclosure of information for which good reason for withholding would exist under section 7(2)(i)Local of the Government Official Information and Meetings Act 1987 (i.e to enable Greater Wellington to carry on without prejudice or disadvantage agreement negotiations).
