Boulcott Golf Club (Inc) September 2007 Stop Bank Reconstruction Submission. Boulcott Golf Club Stop Bank Committee 2006.

Hutt Golf Club Inc. Submission to Hutt River Advisory Committee. Hutt Golf Club Inc.

Dennis Page, a Boulcott St resident, favours the Blue option for the construction of a new stopbank in the Boulcott-Hutt golf courses area. Mr Page is concerned that potential rezoning consequent to the adoption of other options would result in residential housing in protected areas of the Boulcott course. Mr Page was aware of the future stopbank upgrade at the time of property purchase and prefers a grassed stopbank to housing.

Sandy Wallace of 30A Hathaway Avenue expressed opposition to the Blue option for the construction of the stopbank. Ms Wallace reported that her property has been flooded in the past, and she feels that adoption of the Blue option will increase the stormwater flood risk. She favours the Green or Red options.

Barry Jenness of Hathaway Avenue felt that the Councils should take a broader view of the situation. Mr Jenness opposes the Blue option, favours the Red option, but would accept the Green. He maintained that adoption of the Blue option will decrease property values. Mr Jenness encouraged the Councils to promote the merger of the two affected Golf Clubs.

David Graham of 2 Boulcott Street strongly favours the Green option. He is opposed to a carpark near his residence. Mr Graham feels that the amalgamation of the two affected Golf Clubs would be beneficial to Hutt City.

Colin Carter on behalf of the Boulcott Golf Club strongly prefers the Blue option. While the club is sympathetic to the need for flood protection, it wishes to preserve the integrity of both the club and its course. The only way for survival of the Boulcott Golf Club should the Green alignment be adopted is for it to be a golf friendly stopbank probably with batters of 6:1. **Attachment1** contains the Boulcott Golf Club's submission.

Rod Gillespie and Brian Gillespie on behalf of the Hutt Golf Club favour the Red option provided the costs for modifying the golf course were paid for as part of the project and that they were given other land adjacent to the course of equal area to that required for the red option stopbank. Messrs Gillespie feel that the Green option will create a disruptive impact on the clubs viability which will extend well beyond the construction phase. They also said, on the basis of their estimates, the Red alignment will have the lowest total costs. They sought time to explore the viability of merging

with the Boulcott club. Attachment 2 contains the Hutt Golf Club's submission.
