**Claire Pascoe** presented a petition for requesting free carriage of bicycles on trains. Ms Pascoe invited committee members to attend a "Bike Day" on February 23 2008 to try the Wellington-Petone cycle way, and to take their bikes on the train.

**Chris Horne** recommended that occupancy rates and proportion of company cars to private cars entering the region's CBDs in weekday morning peaks, weekday off-peaks, and weekend peaks, be monitored in future Annual Monitoring reports. He is of the opinion that light rail is the best option for public transport in the Ngauranga – Airport corridor.

Mr Horne advocated the abandonment of the Transmission Gully motorway in favour of improved rail infrastructure, and institution of more rapid, reliable and frequent bus and train services.
