• Councillor Burke expressed concern at the quality of a press release on 18 February 2008 relating to the Parks, Forests and Utilities Committee meeting at Porirua and following visit to Whitireia and Battle Hill.

• Councillor Bruce voiced support for Sue Kedgley's call, made during public participation, to halt fumigation of logs with methyl bromide on the Wellington waterfront.

He also reported on the *Cycle Aware Wellington* event held on 23 February 2008, in which he and Councillor Glensor participated. Councillor Bruce expressed concern at the state of the Petone-Wellington cycleway, and urged that it be completed as soon as possible. Councillor Wilde advised that this issue is being addressed by the Regional Land Transport Committee

- Councillor Donaldson commended Officers for organising various site visits, which she found very useful.
- Councillor Greig noted that the Auckland Regional Council has purchased two electric scooters for use by staff.

She also drew attention to the adverse publicity the Northland Regional Council has recently received re alleged failure to clear blocked waterways resulting in flooding. Councillor Greig suggested that Greater Wellington should publicise its ongoing successful work in this field.

- Councillor Wilson discussed the insuring of Councillors' lives by Greater Wellington.
- Councillor Laidlaw expressed concerns about Greater Wellington's vehicle purchasing policy.
