The information contained in this report relates to a legal agreement between parties for a new Johnsonville Bus/Rail interchange. Negotiations are still taking place. Having this part of the meeting open to the public would disadvantage Greater Wellington in commercial negotiations.

Certain portions of the information contained in this report are subject to a mutually understood obligation of confidence between Greater Wellington and the developer. Release would be likely to prejudice the supply of similar information in the future. It is in the public interest that such information should continue to be supplied to ensure Greater Wellington is able to be fully informed. Greater Wellington has not been able to identify a public interest favouring disclosure of this information particular public inproceedings of the meeting that would override these prejudices.
