# Legal Compliance

#### 1. Purpose

To report to the Committee on the Council's legal compliance review.

## 2. Significance of the decision

The matters for decision in this report do not trigger the significance policy of the Council or otherwise trigger section 76(3) (b) of the Local Government Act 2002.

## 3. Background

A legal compliance review has been undertaken in respect of the year ending 30 June 2008 for Greater Wellington and the WRC Holdings Group (excluding CentrePort Ltd which has undertaken its own review). The review uses a checklist covering the major Acts that apply to Greater Wellington. A copy of this checklist is attached. (Refer **Attachment 1**)

#### 5. The Process

The checklist was completed by each division and reviewed by each divisional manager.

#### 6. Results of the review

The only matter noted was that WRC Holdings did not provide their Statement of Intent to the shareholder by 1 March, nor was it finalised by 30 June, as required by the Local Government Act 2002.

The Directors of WRC Holdings delayed the release of the Statement of Intent while they received further information.
