Greater Wellington's Submission on Transit's Draft 2008/09 Land Transport Programme

Thank you for the opportunity to comment on the draft Land Transport Programme (draft LTP). This submission is based on policies of Wellington's Regional Land Transport Committee (the Committee), primarily as set out in the Wellington Regional Land Transport Strategy 2007 – 2016.

We do not wish to be heard in support of our submission.

1. Large Projects

Specific comments relating to each significant item are set out below.

1.1 Rimutaka Corner Easing (Muldoon's Corner)

The following table shows the Committee's expectation compared with the current draft LTP:

We are pleased that the design of this project is underway but remain disappointed that the Committee's recommendation, over many years, to give this project high priority has still not enabled construction of this project to be included in the programme. The Committee has previously agreed that this project be advanced using R funding. We seek inclusion of the construction of this project in Transit's programme as soon as possible.

Preferably it should be added to Table 2 (the list of State Highway activities for 2008/09).

1.2 Melling Interchange

While we support the investigation of this project, we believe this should commence <u>after</u> completion of the Dowse-Petone upgrade which will not be complete until 2010/11 and therefore should be removed from Table 2 (the list of State Highway activities for 2008/09).

1.3 Basin Reserve Improvements

We are pleased to see the Basin Reserve improvements project included in the forecast but it must only proceed if confirmed by the outcome of the Ngauranga to Airport Corridor Study. Therefore, it should be to from Table 2A (the list of State Highway activities that may be undertaken 2008/09).

1.4 SH2/SH58 Grade Separation

We note that this project is not identified for any action over the next three years and request that an allowance be made in the programme to progress design work should it be confirmed by the outcome of the Ngauranga to Airport Corridor Study. Therefore, it should be added to from Table 2A (the list of State Highway activities that may be undertaken 2008/09).

1.7 Terrace Tunnel Tidal Flow

We note that this project is not identified for any action over the next three years and request that an allowance be made in the programme to progress design work should it be confirmed by the outcome of the Ngauranga to Airport Corridor Study. Therefore, it should be added to Table 2A (the list of State Highway activities that may be undertaken 2008/09).

2. Small/Medium Projects (block programme)

We note that Transit has identified a number of relatively low cost safety and efficiency improvement works. However, due to the limited time we had available to review the draft programme we have not reviewed these projects this year.

3. Strategic Studies

We are pleased to note a number of proposals for strategic studies and seek that the regional Technical Work Group is fully involved in all of these studies.

We are particularly pleased that Transit plans to further progress the Grenada to Gracefield Strategic Study in cooperation with both Wellington and Hutt City Councils.

4. Walking and cycling projects

Last year we supported the three walking and cycling projects shown below, noting that one had been added to the two proposals identified the previous year:

- SH1 Teihana Road Pedestrian Facilities (Pukerua Bay)
- SH2 Petone Horokiwi Cycle
- SH1 Paraparaumu Rail overbridge clip on cycle lane (new and committed).

It is disappointing that none of these proposals has yet proceeded to the construction phase. Of particular concern is the SH2 Petone to Horokiwi cycle lane that is to be reviewed again as part of the Grenada to Gracefield study. We request that more resources are invested in progressing these projects much sooner.

It is also noted that these proposals remain well short of addressing the deficiencies and priorities identified in Bullen Consultant's report 'Strategic Cycle Network Priorities' (April 2004). We remain disappointed that Transit has not adequately responded to our 2005, 2006 and 2007 submissions by adding the following identified Wellington Region State Highway cycling improvements to its priority list.

- Wellington region state highway minor works 1=

•	SH2 Ngauranga to Petone, northbound	4
•	SH2 Opaki Bridge	5=

٠	SH1 Ngauranga Gorge, southbound	7=
•	SH1 Peka Peka to Pukehou	10=
•	SH1 Otaki River Bridge	11
•	SH2 Petone to Ngauranga (two way)	12=
٠	SH1 Waitohu Bridge	15

We again note that increased funding of \$30M has been included in the \$225M 'C' funding announced on 27 January 2005 for transport demand management (traffic systems, travel plans, cycling) which should allow for meaningful progress to be made on these projects. The Committee's recommendation to Land Transport NZ in 2007 was that \$5M of C1 funding over ten years should be invested in walking and cycling improvements. Therefore, we cannot see why faster progress cannot be made on addressing identified regional walking and cycling deficiencies and seek a stronger commitment from Transit in this regard.
