# Wairarapa Moana - Proposed annual work programme and budget 2009/10

## 1. Purpose

To seek approval from Council for the 2009/10 work programme for Wairarapa Moana.

# 2. Background

One of the roles of the Wairarapa Moana Establishment Group (WMEG) is to endorse an annual work programme and apply for funding to enable work programmes to be implemented.

Greater Wellington Regional Council (GWRC) has allocated \$100,000 specifically to this project in the 2009/10 financial year to be utilised by 30 June 2010. The work programme detailed has been endorsed by the WMEG to be presented to Council for approval of the 2009/10 budget to be applied to those projects.

There are also other works that will be carried out with the Wairarapa Moana environs by both GWRC and the Department of Conservation (DoC) that are part of our wider organisational responsibilities. Some of those other works are required to meet any statutory requirements and, therefore, are not subject to approval by the WMEG. Those that are non-statutory are considered to be part of this project and are subject to WMEG approval.

Combining this entire work means, in total, the budget for Wairarapa Moana in the 2009/10 funding year before any external funding is sourced will be \$257,180. Please note that these costs *do not include* the cost of staff time from the various agencies allocated to carrying out the work, attending meetings or planning.

# 3. Wairarapa Moana project - GWRC funded 2009/10 work programme

### 3.1 Project budget
