The information contained in this report relates to Greater Wellington entering into negotiations with a transport provider for the potential extension of a ticketing product. Negotiations have not yet commenced. Having this part of the meeting open to the public would disadvantage Greater Wellington if negotiations were to take place as it would reveal the Greater Wellington's negotiation strategy. Greater Wellington has not been able to identify a public interest favouring disclosure of this particular information in public proceedings of the meeting that would override this prejudice.

That the public conduct of the whole or the relevant part of the proceedings of meeting would be likely result indisclosure of information for which good reason for withholding would section exist under 7(2)(i) of the Local Government Official *Information* and Meetings Act 1987 (i.e. enable Greater Wellington to carry on without prejudice or disadvantage negotiations).

This resolution is made in reliance on section 48(1) of the Local Government Official Information and Meetings Act 1987 and the particular interest or interests protected by section 6 or section 7 of that Act which would be prejudiced by the holding of the whole or the relevant part of the proceedings of the meeting in public are as specified above.
