Submissions were considered at the conclusion of the oral presentations. The Subcommittee agreed to make amendments to the draft Regional Freight Plan 2011 as proposed by officers in Attachment 1 to Report 11.212 subject to the following changes being made and/or issues further investigated:

- Request that officers include further data in the draft Plan on the proportion of the freight task undertaken by each mode
- Request that officers include additional data in the draft Plan on the contribution of trucks to road crashes
- Remove “can” from recommendation to point 1 from submission 3
- Request that officers amend the wording of the reference in the draft Plan to the Western Link Road and Mackays to Peka Peka Expressway to better reflect what appears in the Western Corridor Plan
- Request that officers amend wording of recommendation to point 5 of submission 5 referring to “run back and forth repeatedly”
- Request that officers include additional information in the draft Plan on the value of the freight task if available

- Request that officers include a clear title to explain the chart of page 4 of the draft Plan
- Request that officers add explanatory text in the draft Plan about the predicted increase in airfreight and the proportion of the total freight task this represented
- Request that officers add data on the truck trips along The Esplanade (having checked with Hutt City Council)
- Amend Action 3 in the draft Plan to delete “increase economic efficiency of road freight”
