Statutory acknowledgments (ss 26 – 27; 30 -31)	<p>Recognise the association between Ngati Toa Rangatira and a particular statutory site or area. It enhances Ngati Toa Rangatira's ability to participate in specified Resource Management processes in relation to the specified site or area. The areas or sites are:</p> <ul style="list-style-type: none"> • Cook Strait • Te Awarua-o-Porirua Harbour • Thoms Rock/Tokahaere • Kapukapuariki Rocks • Toka-a-Papa Reef • Tawhitikuri/Goat Point • Wellington Harbour • Balance of Mana Island • Red Rocks Scientific Reserve • Pukerua Bay Scientific Reserve • Oteranga Bay Marginal Strip • Queen Elizabeth Park • Whareroa Farm • Te Onepoto Bay 	<p>GWRC is required to have regard to areas covered by the statutory acknowledgement and specifically:</p> <ul style="list-style-type: none"> - have regard to the statutory acknowledgment in deciding whether the trustee of the Toa Rangatira Trust is an affected person (s 95E of the RMA 1991) - provide summaries of applications for activity within, adjacent to, or directly affecting a statutory area - provide a copy of any notice of application served under s145(10) of the RMA 1991 - record the statutory acknowledgements to all statutory plans that wholly or partly cover a statutory area

Onehunga Bay vesting (s 72)	Recreation reserve status revoked and vested in fee simple in Ngati Toa Rangatira. It will be reclassified as a historic reserve subject to s 18 of the Reserves Act 1977 and named the Onehunga Bay Historic Reserve.	The reserve will be managed by the joint Whitireia Recreation Reserve Management Board which includes 3 GWRC appointees.
Te Onepoto Bay vesting (s 74)	Recreation reserve status revoked and vested in fee simple in Ngati Toa Rangatira. It will be reclassified as a recreation reserve subject to s17 of the Reserves Act 1977 and named Te Onepoto Recreation Reserve.	Reserve will be managed by the joint Whitireia Recreation Reserve Management Board which includes 3 GWRC appointees.
Whitireia Urupa vesting (s 80)	Recreation reserve status revoked and vested in fee simple in Ngati Toa Rangatira. It will then be set aside as a Maori reservation as if it were set apart under s338(1) of te Ture Whenua Maori 1993.	The reserve is excluded from the Whitireia Recreation Reserve which will be managed by the joint management board.
Geographic Names (ss100-103)	<p>There will be 11 place name changes in the North Island – 7 are new names and 4 are alterations to existing names as follows:</p> <p><i>New names</i></p> <ul style="list-style-type: none"> • Taupo Point • Kapukapuariki Rocks • Mount Porirua • Haukopua Point • Motuhara Point • Te Ana-o-Hau • Toka Potaka Rock 	The New Zealand Geographic Board Act 2008 requires that GWRC uses the official spellings for place and geographic names, and railway lines. GWRC will need to ensure this requirement is met and update its databases and communications materials accordingly.

	<p><i>Altered Names</i></p> <ul style="list-style-type: none"> • Colonial Knob to Rangituhi/Colonial Knob • Goat Point to Tawhitikuri/Goat Point • Porirua Harbour and Porirua Harbour (Pauatahanui Inlet) to te Awarua-o-Porirua Harbour • Tokaapapa Reef (Grandfather Rock) to Toka-a-Papa Reef <p>The process of recognising the name changes involves New Zealand Geographic Board publishing a notice in the Gazette specifying the new place names and their locations.</p>	
Poutiaki Plan (ss145-148)	Recognises the role of Ngati Toa Rangatira as a kaitiaki of Cook Strait and the coastal marine area in Porirua Harbour, Port Underwood and Pelorus Sound. Ngati Toa will issue a Poutiaki Plan which identifies iwi values and principles in relation to these areas.	GWRC is required to take the Poutiaki Plan into account to the extent that its content has a bearing on resource management issues when preparing or changing a regional policy statement or regional coastal plan that covers all or part of the poutiaki coastal marine area.
Whitireia Park Redress (ss 149 – 156)	A joint Board with equal membership from GWRC and Ngati Toa Rangatira Trust established as the administering body of the Whitireia Recreational Reserve and the Onehunga Bay Historic Reserve and the Te Onepoto Recreation Reserve.	GWRC and Ngati Toa will appoint 3 members each for a term of up to 5 years. The joint board is required to prepare a management plan in accordance with s 41 of the reserves Act 1977. Section 155 of the Act sets out processes for joint board meetings.
Queen Elizabeth Park Campground site – change in status (s158)	The reserve classification for the campground site changes from a recreation reserve to a local purpose reserve for campground purposes. Ngati Toa Rangatira Trust will be the administering body of the campground site.	GWRC ceases to be appointed to control and manage the campground site.
