1. Contract between Greater Wellington Regional Council and Capacity *Infrastructure* Services Limited relating bulk to water supply services

The information contained in this report relates to the proposed contract between Greater Wellington Regional Council (GWRC) and Capacity *Infrastructure* Services Limited (Capacity) for the provision of bulk water supply services. Release of this information would be likely to prejudice GWRC's negotiations with Capacity to achieve finalisation of the contract. GWRC has not been able to identify a public interest favouring disclosure of this particular information in public proceedings of the meeting that would override this prejudice.

That the public conduct of the whole or the relevant part of the proceedings of the meeting would be likely to result in the disclosure of information for which good reason for withholding would exist under section 7(2)(i) of the Local Government Official Information and Meetings Act 1987 (i.e. to protect information where the making available of that information would belikely unreasonably to prejudice disadvantage the ability of **GWRC** carry onnegotiations).

2. Permits Nicola Daly, Senior Associate, DLA Phillips Fox, to remain at the meeting after the public has been excluded because of her knowledge relating to the contract between GWRC and Capacity relating to bulk water supply services. This knowledge, which will be of assistance in relation to the matter discussed, is relevant to that matter because it is the subject of the report.

This resolution is made in reliance on section 48(1) of the Local Government Official

Information and Meetings Act 1987 and the particular interest or interests protected by section 6 or section 7 of that Act which would be prejudiced by the holding of the whole or the relevant part of the proceedings of the meeting in public are as specified above.

That the Council:

- 1. Receives the report.
- 2. Notes the content of the report.
- 3. Appoints the Chief Executive Officer of Capacity Infrastructure Services Limited as its officer to exercise the Council's powers under section 171, 173 and 181 of the Local Government Act 2002.
- 4. Directs the Council's Chief Executive to issue a warrant as evidence of the Council's powers delegated to the Chief Executive of Capacity Infrastructure Services Limited.
- 5. Authorises the Council's Chief Executive to delegate further powers to the appointed officer, except those powers retained by Council, as may be necessary to enable Capacity Infrastructure Services Limited to provide management services in accordance with its contract with Wellington Regional Council.
- 6. Authorises the Council's Chief Executive, when required under legislation, to appoint such other officers of Capacity Infrastructure Services Limited, as the Council's Chief Executive deems appropriate, as officers of the Council for specified purposes and delegate powers to the appointed officers, and to issue warrants to such officers, when required.
- 7. Notes that any officer appointed directly by the Council or its Chief Executive to assist with the provision of management services under the contract may sub-delegate their powers, but a person delegated powers by an officer may not sub-delegate their powers.
- 8. Delegates financial authority to the Board of Capacity Infrastructure Services Limited, as set out in section 4.1 of this report.
