# Chair's update for WREDA

#### Purpose

# Background

2 WREDA was established in December from Positively Wellington Tourism, Positively Wellington Venues and Grow Wellington/Creative HQ. Major Events from Wellington City Council (WCC) will join WREDA following the arrival of the new Chief Executive.

#### **Progress to date**

- 3 The search for a new CEO is near completion and I will update the Committee at the meeting.
- 4 Until the new CEO is on board each of the component parts of WREDA will continue as they have previously with each of the CEOs reporting through to the Board. The Major Events team of WCC will transfer to WREDA following the arrival of the new CEO.
- 5 The recommendation for the appointment of the tenth director with film experience will shortly be with the Appointments Group/shareholders for consideration.
- 6 The Board of WREDA has met a number of times and now has a better understanding of the challenges and opportunities that are in front of us and the region.
- 7 Staff in WREDA have been kept fully informed of developments and there is an intranet site available for WREDA communications
