Waiohine Floodplain Management Plan governance and project delivery structure – recommendations from Wairarapa Committee

1. Purpose

To seek Environment Committee endorsement of the Wairarapa Committee's recommendations to Council on the Waiohine Floodplain Management Plan (FMP) governance and project delivery structure.

2. Wairarapa Committee recommendations

The Wairarapa Committee considered Report 17.258 (attached as **Attachment** 1 to this report) at its meeting on 3 August. It recommended that Council:

- a. revokes the Draft FMP that was approved for consultation by the Environment Committee on 10 May 2016; and
- b. establishes a Waiohine FMP Steering Group; and
- c. adopts terms of reference for the Waiohine FMP Steering Group as set out in Attachment 1 of Report 17.258.

3. The roles of the Wairarapa Committee and the Environment Committee

In the context of the Waiohine FMP process the Wairarapa Committee may consider and make recommendations to Council on any matters relevant to the Wairarapa, including but not limited to flood protection. The Environment Committee has the specific responsibility to monitor/oversee the development and implementation of floodplain management plans across the region, including the Waiohine FMP.

It is therefore appropriate that the Environment Committee consider and endorse the recommendations of the Wairarapa Committee before they are considered by Council.
