| 3    | That the Council should<br>comprise 11<br>Councillors:<br>Wellington/Porirua – 6,<br>Kapiti – 1, Hutt Valley –<br>3, Wairarapa – 1.   | Rejected. This proposal would not<br>provide effective representation for<br>Wellington Region's distinct<br>communities of interest. Also, it<br>would not provide fair representation<br>for the electors of the Kapiti<br>Constituency.  |
| 4    | That the Council should<br>comprise 14 members,<br>with Tawa included in<br>the Wellington<br>Constituency (total six<br>Councillors), and the<br>Porirua and Kapiti areas<br>combined into a single<br>constituency electing<br>three Councillors. | Rejected. The Tawa area shares a<br>common regional community of<br>interest with Porirua; splitting the<br>Porirua-Tawa Constituency would<br>not provide effective representation<br>for the Porirua-Tawa area. This<br>proposal would not provide effective<br>representation for the distinct<br>Porirua and Kāpiti Coast regional<br>communities of interest. Also, it<br>would not provide fair representation<br>for the electors of the Upper Hutt and<br>Wairarapa constituencies. |
| 5    | That the Kāpiti Coast<br>Constituency should<br>elect two Councillors.  | Rejected. This proposal would not<br>provide for fair representation of the<br>electors of the Kāpiti Coast<br>Constituency.  |
