3 Public participation

Denise Church, Predator Free Wellington, tabled a presentation and spoke to agenda item 8 – Crown Funded Covid Recovery Projects – progress update, specifically on the Predator Free Wellington update.

4 Confirmation of the Public minutes of the Environment Committee meeting on 26 November 2020 – Report 20.439

5 Wainuiomata Mainland Island threatened species sanctuary update – oral report

Councillor Nash provided the Committee with an update. Councillor Nash advised that there has been a meeting between himself, Greater Wellington officers, Taranaki Whānui and Department of Conservation. The Minister of Finance (Hon. Grant Robertson, MP) indicated his interest to visit.

Noted: The Committee requested that a standing item on the Wainuiomata Mainland Island threatened species sanctuary (Report 20.466) be added to the agenda for future meetings.

6 Confirmation of the Public minutes of the Toitū Te Whenua Parks Network Plan 2020-30 Hearing Subcommittee meeting on 23 November 2020 – Report 20.438

7 Update on progress of actions items from previous Environment Committee meetings – February 2021 – Report 21.6 [For Information]

Al Cross, General Manager Environment Management, spoke to the report.

8 Mayoral Taskforce update – oral report

Mike Mendonca, Chief Resilience Officer, Wellington City Council (WCC) spoke to the report. A presentation was tabled.

Mr Mendonca advised the Committee that WCC appointed a mayoral taskforce to investigate the issues with the three waters network (the Mayoral Taskforce) and to recommend back to WCC an action plan.

The Mayoral Taskforce looked at the role of WCC and Wellington Water Limited (WWL) and found that a fundamental reorganisation of the funding, governance, asset ownership and management of water is required. WCC has formally received the report, which included 48 recommendations, but is yet to receive officer advice on the recommendations.

Many of the pipes are old, and the condition is unknown. Most of the focus is on the seismic resilience of these pipes, but the extent of the damage to the pipes after the recent earthquakes in unclear. It is clear that the sewerage and stormwater overflow needs to be disconnected, and to improve green infrastructure utilising stormwater. Drinking water pipes lose between six and 32 percent of water, but it is unclear the extent of the loss. Investigations will need to be done to understand the issues and options to fix this, such as water metering.

Community participation will be a focus area. Engagement with communities will be important for catchment management. This will help performance and transparency, by not allowing the three waters network to be out of sight and out of mind.

9 Crown Funded Covid Recovery Projects – progress update – Report 21.51 [For Information]

Wayne O'Donnell, General Manager Catchment Management, spoke to the report.

That the Committee requests officers to explore and report back to Council on a targeted rate to support predator free efforts in the Wellington City and the viability of inclusion in the draft Long Term Plan consultation document.

10 Whaitua update – Oral report

Tim Sharp, Programme Manager – Whaitua, updated the Committee on the whaitua programme.

Kāpiti Whaitua

Officers are aiming to start the whaitua process for Kāpiti June/July 2021. Officers want to get the information in place and have an agreement with mana whenua before starting the process. A programme is underway to gather scientific information to fill any gaps, which will be finished this year. This was a learning from previous whaitua programmes,

where the science programme was undertaken at the same time as the whaitua programme. Appropriate funding arrangements of mana whenua to support their involvement in whaitua is being investigated.

East Wairarapa Whaitua

Officers aim to begin the East Wairarapa whaitua programme in 2022, subject to Long Term Plan funding.

Te Whanganui-a-Tara Whaitua

The Te Whanganui-a-Tara Whaitua Committee intends to bring the final draft Whaitua Implementation Programme to Council to adopt on 27 May 2021. It is in the final stages and is testing the draft recommendations and refining these. The Co-Chairs (Sam Kahui and Louise Asking) met with Hutt City Council councillors, which has doubled funding for the three waters network in its District and Long Term Plans.

SUBMISSIONS ON THE NAVIGATION AND SAFETY BYLAWS REVIEW

Te take mō te pūrongo Purpose

1. To advise the Environment Committee (the Committee) of the process for considering submissions received on proposed amendments to the Wellington Region Navigation and Safety Bylaws 2009.

He tūtohu

Recommendations

That the Environment Committee:

- 1 **Notes** that submissions were received on the proposed amendments to the Wellington Region Navigation and Safety Bylaws 2009.
- 2 Agrees to receive and consider late submissions.
- Agrees to hear four submitters, deliberate, and recommend adoption of the amended bylaws at the next Environment Committee meeting on 13 May 2021.

Te tāhū kōrero Background

- 2. The Local Government Act 2002 (the LGA) requires Council to review the Regional Navigation and Safety Bylaws every 10 years, to inform the public of proposed amendments to the bylaws, and call for submissions.
- 3. An internal review found that changes to the 2009 bylaws are required to:
 - a move towards national consistency with other regional councils
 - b ensure we are addressing risks raised through our Port and Harbour Marine Safety Code work
 - c include current practices into the bylaws that are not otherwise documented
 - d ensure the Bylaws reflect best practice for safety on the water
 - e incorporate minor editorial changes to clarify the existing Bylaws.
- 4. In September 2020 the Committee approved the Statement of Proposal for consultation on the proposed changes to the Navigation and Safety Bylaws (Review of the Wellington Region Navigation and Safety Bylaws 2009 (Report 20.312)). Greater Wellington called

for comments and submissions on the proposed amendments by 30 November 2020 through the 'Have your say' platform (Review of the Wellington Region Navigation and Safety Bylaws 2009 (Report 20.312)).

Te tātaritanga Analysis

- 5. Greater Wellington received 12 written submissions on the proposed changes to the bylaws.
- 6. Two submissions, from the Department of Conservation and KiwiRail, were received after the closing time. Officers recommend that these late submissions be accepted and considered by the Committee.
- 7. Four submitters wish to be heard in support of their submissions.
- 8. Given the small number of submitters who wish to be heard, it is proposed that the Environment Committee hear these submitters at their next meeting on 13 May 2021 rather than form a subcommittee or schedule a separate hearing.
- 9. In line with other submission and hearing processes, it is proposed that submitters are allocated five minutes to speak. This time allocation would be the same for individuals and those speaking on behalf of organisation. The five minutes also includes time for the Committee to ask questions.
- 10. It is proposed that deliberations commence following the hearing of oral presentations.
- 11. The Committee must consider all written submissions, regardless of whether the submitter spoke to it. The Committee must also consider all of the feedback that was received on the consultation document.

Ngā hua ahumoni Financial implications

12. There are no financial implications from this report.

Ngā tikanga whakatau Decision-making process

13. The process for deciding these matters is prescribed explicitly by section 83 of the LGA. That prescribed process is the special consultative procedure.

Te hiranga Significance

14. Officers considered the significance (as defined by Part 6 of the LGA) of the matters for decision, taking into account Council's Significance and Engagement Policy, and Greater Wellington's Decision Making Guidelines. Officers consider that the matter of considering the submissions is of low significance due to its administrative nature.

Te whakatūtakitaki Engagement

15. This report records the outcomes of public consultation, and affirms the process for Council hearing and considering that engagement.

Ngā tūāoma e whai ake nei Next steps

- 16. Officers will prepare a summary of submissions and recommended changes to the Bylaws for the next meeting of the Environment Committee.
- 17. Following the hearing and deliberations, the Committee will need to prepare a report to Council, setting out its recommendations on the adoption of the bylaws.
- 18. Each person who made a submission or provided feedback and who provided a contact address will, subsequent to Council adopting the bylaws, receive a response outlining Council's decision, and any key changes.
- 19. A press release will be published, outlining Council's decisions and any key changes, and be made available on Greater Wellington's website.
