6 Puketahā – Wainuiomata Ecosanctuary Feasibility Study – Report 22.33

Wayne O'Donnell, General Manager, Catchment Management, introduced the report. Jack Mace, Director of Operations, Department of Conservation, Lee Hunter, Taranaki Whanui and Jim Lynch, Feasibility Study author, spoke to the report.

proposed sanctuary site within Wainuiomata Orongorongo Water Collection Area, including maintaining pest control activities at current levels.

Dairy production is down following issues in the spring with many cows not reaching peak production.

The Farming Reference Group has noted that wheat prices have increased, in part driven by global events such as the unfolding situation in Ukraine, and weather has created difficulty in completing harvest, with the flow on effect driving up animal feed, domestic flour and bread prices.

ENVIRONMENT/CATCHMENT UPDATE

Te take mō te pūrongo Purpose

1. To inform the Environment Committee (the Committee) of Greater Wellington Regional Council (Greater Wellington) activities relating to the Committee's areas of responsibilities.

Te horopaki Context

Regional issues

- 2. Land Management are preparing an application for the next 4-year funding round of the Ministry of Primary Industries Hill Country Erosion Fund. This will secure funding for hill country erosion works from 2023-2027. Key changes with this funding round include greater incentives for native plants and aligning with emissions trading scheme drivers that are influencing landowner decision making.
- 3. The Flood Protection department is continuing to progress the regional flood vulnerability study to support the regional climate change risk assessment. This project is developing a regional rapid flood hazard model to analyse the future impacts of climate change on flood hazard. This project is due in the next month.
- 4. Flood protection have been working closely with ICT to develop a Digital Roadmap for flood risk management that will seek to improve data management, digital communications and improvements to the advisory service. This project is due to be completed in the next month.
- 5. Flood damage repairs resulting from the December 2021 and February 2022 are continuing. Specific details on each piece of work are outlined below.
- 6. We have published a report on air quality monitoring around CentrePort to capture baseline data before NZ signs up to MARPOL Annex VI regulations to limit air pollution from ships.
- 7. Biosecurity's Regional Possum Predator Control programme is 59 percent complete, with 30,112ha of possum control and 3,163ha of mustelid control carried out so far.
- 8. Transmission Gully opened to the public on 30 March 2022. Addressing works and approvals that the Project has deferred until after road opening are now the focus. These are associated with matters such as stream works, changes to fill sites, planting plans and supplementary planting, fish passage remediation works and stormwater

system monitoring and maintenance. The Project has advised that any works on site will be very limited over the winter period.

- 9. The Minister of Conversation Hon Kiritapu Allan launched Te Mana o Te Taiao Aotearoa New Zealand Biodiversity Strategy Implementation Plan on 20 April 2022. This follows the launch of the Strategy in 2020. The plan prioritises specific goals set down in the strategy and identifies central and local government actions to achieve a number of these goals by 2025. The Biodiversity department will provide a briefing to Council in June outlining Greater Wellington's role in implementation.
- 10. The summer boating safety campaign has come to an end, a report on the activities undertaken and results will shortly be provided to Maritime NZ to reconcile against the funding provided.

Whaitua-specific issues

Te Whanganui-a-Tara

- 11. Work is continuing on the implementation of the Co-Government funded Climate Resilience projects (Flood Protection). A variation has been submitted to extend our contract term with Kānoa (Ministry for Business, Innovation and Employment) by six months to reduce the cost of rock purchase by approximately \$1.8 million. We have received a positive response to the proposal and are awaiting final approval.
- 12. Flood Protection continues to work with Hutt City Council and Wellington Water over the provision of flood hazard information to support the District Plan review process currently being progressed by Hutt City Council. This is tracking towards the release of the Draft District Plan in September 2022.
- 13. Flood Protection has started works on the Waiwhetu Floodplain Management Plan which will seek to identify options to provide a 1% AEP + Climate Change level of protection to the Waiwhetu catchment. This initial work includes scoping and procuring support to deliver technical investigations and engaging with key stakeholders and partners to develop a governance structure to support delivery.
- 14. Flood damage repairs to the Korokoro debris arrestor are complete.
- 15. The Parangarahu Lakes outlets remediation report, funded by Biodiversity and supported by Flood Protection expertise, was presented to Te Rōpū Tiaki for consideration. This report advised on practical options for improving the lakes' natural capabilities to connect to sea that appears to be restricted currently potentially affecting the mouri of the lakes. Te Rōpū Tiaki are reviewing the report.
- 16. A report, *East Harbour Regional Park DNA Survey: Red Deer Abundance,* has been finalised and received. This was funded by Biodiversity to inform the future management of deer within the Regional Park and key native ecosystem (KNE) site and provide a good data platform for ongoing discussions with the local communities.
- 17. The Environment Court hearing for the direct referral for the RiverLink Resource Consent application concluded 29 April 2022, closing submissions 12 May 2022. A decision from the Environment Court will be released after that.
- 18. As previously reported the proposed Shelly Bay resource consent has been lodged, however was returned (under Section 88 of the Resource Management Act 1991 (RMA))

as there was not enough information to assess the effects of the activity. Since then, workshops have been held and a site visit undertaken with all the experts, to ascertain what information is required.

- 19. Staff have received an information request (under the Local Government Official Information and Meetings Act 1987) about wallabies in the Kaitoke area. We believe that the last wallaby in the area has been killed but we are continuing to monitor the situation.
- 20. The Predator Free Wellington team are having to avoid servicing equipment in the vicinity of the squatters in Mahanga Bay but are working to resolve the issue with landowners.
- 21. Biosecurity is carrying out ungulate control for Hutt City Council. The South Makara and Hutt Water Collection Area-Kaitoke aerial 1080 operations are both planned for May 2022.
- 22. Harbours department have provided information, by way of a request from Maritime NZ, to the coroner who is investigating a drowning.
- 23. The dredging work in the harbour and along some of CentrePort's berths undertaken for both CentrePort and Greater Wellington was completed between 12 and 25 April 2022.
- 24. The end of summer has seen several instances of speeding of Personal Watercraft (jet skis) and small vessels obstructing shipping. These incidents are being followed up by our Harbours department.

Ruamāhanga

- 25. Progress is being made with Land Management's proposed nursery development at Carterton Wastewater Treatment Plant (WWTP). The WWTP Advisory Group is considering land use options and is expected to make their decision in June. At this stage the new Greater Wellington nursery is looking like the favourable option.
- 26. Meetings have been held with both Carterton District and South Wairarapa District Councils' water race committees where Land Management staff have highlighted the stock exclusion regulations that take effect on 31 July 2022. Good Management Practice incentive programmes are being tailored to support water race users to make the necessary farm system changes.
- 27. Erosion protection construction work will soon begin in Masterton on the Ruamāhanga River, adjacent to the historic Masterton landfill. This project is one of fifteen Co-Government funded Climate Resilience projects currently being implemented. The project is the first of three-stages, protecting local residents and their homes as well as preventing the landfill from eroding into the awa.
- 28. Following the granting of resource consent to allow the continued operation of the Geoffrey Bundle Barrage Gates, an Operational Environmental Management Plan was submitted to, and certified by, Environmental Regulation. The next stage is the formation of a working group to determine alternative operating regimes for the Barrage Gates in anticipation of the review of the Lower Wairarapa Valley Development Scheme.

- 29. Flood Protection continues to work with the Wairarapa Councils over the provision of flood hazard information to support the Combined District Plan review process currently being progressed. This is tracking towards the release of the Draft District Plan in September 2022
- 30. The Waiohine River Plan has been adopted by Council and work is progressing to plan the implementation of the actions identified with the community group.
- 31. A meeting has been set up with the Chief Executives of the Wairarapa district councils for 15 June 2022 to discuss future aggregate supply in the Wairarapa.
- 32. A field trip to Tauweru Farm was the first event in this year's Restoration Day series on 22 April 2022. The farmer shared learnings about wetland restoration and the benefits of planting and fencing off wetlands. The rest of the programme includes an online conference on 28 May 2022 and three more field trips, all in the Ruamāhanga Whaitua.

Te Awarua-o-Porirua

- 33. The reports of the 2020 Wellington and Porirua Harbour sediment surveys are now available. These four-yearly assessments of sediment quality and invertebrate community health focus on impacts of stormwater contaminants. Contaminants remain an issue but have not increased significantly over the last 18 years.
- 34. The 5 yearly Comprehensive Dam Safety Reviews (CDSRs) have been completed for the Stebbings and Seton Nossiter flood detention dams. The CDSRs will set the forward work programme for the dams and ensure that we are well placed to comply with the new Dam Regulations that will take effect in 2024.
- 35. Flood damage repairs to the Porirua Stream debris arrestor are complete.
- 36. The speeding vessels in Pauatahanui Inlet are proving elusive despite some focused efforts. However, we are following up with several water users and if anything, we are providing targeted education to some boat owners.
- 37. The Porirua wastewater treatment plant discharge consent hearing will commence the week of 13 June 2022.
- 38. We are forecasting issues with plant supply for restoration projects in the Porirua Whaitua with Greater Wellington and Porirua City Council planning to increase the numbers of plants they use in this area. To help mitigate this we are supporting an upgrade of Te Rito Gardens, a local community plant nursery run using a social enterprise model by a not for profit trust. This will allow this nursery to increase plant production by 60 percent and ensure good plant quality. This is in line with how Greater Wellington is supporting other community and government funded nurseries in the region.

Kāpiti Coast

- 39. Flood Protection staff are working with Ngā Hapū o Ōtaki to scope a project to develop a management plan for the Ōtaki quarry lake. A Tiriti House approach is proposed within each level of the project governance.
- 40. Flood Protection staff are working with WSP to design a shared path connecting Te Roto Road (near the Ōtaki racecourse) to Greater Wellington owned land near the Ōtaki

quarry lake, and on to both the Ōtaki River and to the proposed shared path along the new expressway.

- 41. Flood Protection are working to understand the effects of climate change and gravel build up on the level of service in the Waikanae Catchment. We are continuing to support the Ki uta ki tai group facilitated by the Department of Conservation.
- 42. Flood Protection staff are working with Fletcher Construction to resolve outstanding asbuilt items and snags relating to the Chrystalls Stopbank upgrade.
- 43. Flood Protection staff are working with the Friends of the Waikanae River to identify and prepare a native planting site to be planted this winter as agreed during the Jim Cooke Park stopbank upgrade project.
- 44. The first aerial spraying drone operation of blackberry at Te Hapua wetland complex KNE site was undertaken successfully. Biodiversity, and a representative from Ngā Hapū o Ōtaki (who co-own the resource consent) observed the operation undertaken by contractors and assisted by Biosecurity.
- 45. Black coral has been formally recorded at the northern point of Kapiti Island. This is exciting as these delicate, often deep water, corals are only found in a handful of locations around the country, most famously Fiordland. We are working with Department of Conservation and Ngāti Toa to consider our approach to managing threats in the area.
- 46. Argentine ant control work has been carried out at QEP and around Kapiti Boat Club to minimise the risk of transfer to Kāpiti Island.
- 47. On 31 March 2022 the High Court heard the appeal against conviction of the offenders in Kapiti wetland case (in which the main offender was imprisoned). The judge, dismissed the appeal and ruled in favour of Greater Wellington stating: *"I am satisfied no error, irregularity or occurrence in relation to, or affecting the appellants trial before the District Court occurred such that either a "real risk" to the outcome of the trial occurred, or that the trial was in any way unfair."*

Wairarapa Coast and Eastern Hills

- 48. Biosecurity is controlling pest plants at Owahanga, Mataikona, Riversdale, Tora and Cape Palliser KNE sites.
- 49. Pest animal culling operations continue at GW's Stoney Creek Forest. Biosecurity and Land Management staff recently undertook a night shooting operation with thermal imaging gear and culled 21 deer and 3 pigs in one night.
- 50. The six eastern Wairarapa Catchment Schemes are holding their annual meetings in May. They each have submitted against the proposed changes in the Revenue and Financing Policy. Officers are working through options to satisfy the concerns of the scheme members, which mainly is based on an undesired implication of the change that will dissolve the scheme boundary and therefore dilute the level of service.

Two projects over 15 sites (3 sites are *complete*, 1 is currently *under construction*)



J4N Ruamahanga River Riparian Planting

- Site prep for winter 2022 planting is in the final stages of completion (20 Ha)
- Pest rabbit control activities are continuing
- Stock fencing of planting sites to start shortly
- Planting to start this month if soil moisture levels allow



Predator Free Wellington

- Support for the project remains high.
- Permissions to operate on private land in the next phase of the operation is approximately 50% complete.
- Major strides forward in our trial site Oruaiti Reserve. Evidence of rats is now extremely localised to one small area.
- Lowest month on record for rat catches.
- Applications are with MPI to licence some of our staff as approved handlers for Pindone rat and possum toxin.
- Work has commenced on the Buffer project with volunteers beginning installations of devices at Tawa Reserve



1 Billion Trees

- Land Management Advisors have completed status check-ins for 2022 planting jobs to finalise planting projects and ensure sufficient planting is undertaken.
- Pre-spraying of planting sites will begin in March to ensure planting can begin as soon as conditions allow.
- The iwi liaison role has compiled a Māori tree and plant use document based on Akura species list.
- The Riparian programme is on track for on-budget winter planting.



Improving Fish Passage Project

- Employed our Project field team; Senior Biodiversity Ranger and Biodiversity Ranger.
- The Project Team visited Horizons Regional Fish Passage Project Team to gain insight into how they are operating their project to gains some of their learnings.
- Confirmed Boffa Miskell as the contractor to develop fish passage training package.
- The Project Team completed a confined spaces training course and the field team also completed a fish passage assessment training day.
- Held second Project Governance Group meeting to approve the Quarter 3 report and a draft Annual work plan for next financial year.
