Proposed Change 1 to the Regional Policy Statement for the Wellington Region

#### Role of Waka Kotahi

Waka Kotahi is a Crown entity with its functions, powers and responsibilities set out in the Land Transport Management Act 2003 (LTMA) and the Government Roading Powers Act 1989. The primary objective of Waka Kotahi under Section 94 of the LTMA is to contribute to an effective, efficient, and safe land transport system in the public interest.

An integrated approach to transport planning, funding and delivery is taken by Waka Kotahi. This includes investment in public transport, walking and cycling, local roads and the construction and operation of state highways.

In the 2018-2021 National Land Transport Programme, Waka Kotahi has allocated significant investment in the Wellington Region to the improvement, operation and maintenance of the State Highway network, including public transport investment, walking and cycling and transport planning. In addition, Waka Kotahi is a co-funder of the local roading network.

Overall, Waka Kotahi has an interest in the Proposed Change 1 to the Wellington Regional Policy Statement as a result of its role as a:

- Transport investor to maximise effective, efficient and strategic returns for New Zealand;
- Planner of land transport networks to ensure the integration of infrastructure and land use so as to support liveable communities and the development of an effective and resilient land transport network for customers:
- Provider of access to and the use of the land transport system to shape smart, efficient, safe and responsible transport choices; and
- Manager of the state highway network to deliver efficient, safe and responsible highway solutions for customers.
- 3. The specific provisions of the proposal that this submission relates to are:

### Climate Change

Waka Kotahi note that the outcomes proposed by the RPS have gone beyond that sought by the Emission Reduction Plan. Waka Kotahi looks forward to working with Greater Wellington Regional Council (GWRC) through the upcoming stages of the Plan Change process, as the Central Government direction evolves.

### Medium Density Residential Standards

Waka Kotahi supports the intent and content of the National Policy Statement on Urban Development (NPS-UD). This Policy Statement recognises the national significance of having well-functioning urban environments that enable people and communities to provide for their social, economic and cultural well-being and for their health and safety. The NPS-UD has a strong focus on ensuring that increased densities are provided in the



most accessible parts of urban areas, where communities are able to access jobs, services and recreation by active and public transport modes.

Waka Kotahi also supports the requirements of the Resource Management (Enabling Housing Supply and Other Matters) Amendment Act 2021. It seeks the full implementation of these requirements, including the introduction of the Medium Density Residential Standards (MDRS) and related provisions in eligible zones. These standards should only be modified to accommodate qualifying matters and should be modified only to the extent required to accommodate these matters. Qualifying matters should be supported by a strong evidence base to ensure a robust application.

Alongside GWRC, Waka Kotahi is a participant to the Wellington Regional Leadership Committee. Waka Kotahi supports incorporating the Wellington Regional Growth Framework into the RPS and looks forward to continuing engagement on the Future Development Strategy with GWRC and other partners.

Waka Kotahi is working alongside other Government Organisations to enable early identification of transportation needs and the design and development of well-functioning areas in a timely way which responds to our Government Directives.

# National Policy Statement for Freshwater Management

A key aspect of Proposed Change 1 is to start the implementation of the National Policy Statement for Freshwater Management 2020 (NPS-FM), which sets the direction for freshwater management in New Zealand through the framework of Te Mana o te Wai. Waka Kotahi has reviewed the draft Regional Policy Statement and considers that the provisions imposed adequately align with the requirements of the NPS-FM, however, notes that the amendment to the NPS-FM is impending so any changes as a result of this will need to be taken into account.

## Indigenous Biodiversity

Waka Kotahi have identified several inconsistencies with the Exposure draft of the National Policy Statement for Indigenous Biodiversity – Exposure draft, June 2022 (NPSIB). The inconsistencies create the opportunity for misinterpretations and perverse outcomes (potentially prohibiting activities provided for in the NPSIB). Waka Kotahi request that amendments be made, as suggested in Table 1, and provision for the relevant sections of the RPS to be amended once the NPSIB comes into effect.

- 4. The changes requested are made to:
  - a. Ensure that Waka Kotahi can carry out its statutory objective and functions
  - b. Reduce interpretation and processing complications for decision makers
  - c. Provide clarity for all policy statement users
- 6. Further points are summarised in Table 1, which forms the bulk of our submission. Where a provision is not specified in Table 1 below, Waka Kotahi generally supports the way it is drafted.
- 7. Waka Kotahi NZ Transport Agency (Waka Kotahi) could not gain an advantage in trade competition through this submission.
- 8. Waka Kotahi would like to be heard in support of this submission.
- 9. If others make a similar submission, Waka Kotahi will consider presenting a joint case with them at the hearing.



10. We seek the following decision from the local authority:

Amend the provisions of Proposed Change 1 to the Regional Policy Statement for the Wellington Region as detailed in Table 1 (attached) including such further, alternative or consequential relief as may be necessary to fully achieve the relief sought in this submission.
