

## FULL PUBLIC NOTICE

Public notification of Addendum 2 to the Summary of Decisions Requested on Proposed Change 1 to the Regional Policy Statement for the Wellington Region under Clause 7 of Schedule 1 of the Resource Management Act 1991. The Addendum corrects errors and omissions in the Summary of Decisions Requested.

Greater Wellington gives notice of a second Addendum to the Summary of Decisions Requested and calls for further submissions on the submission points in the Addendum only.

On Monday 5<sup>th</sup> December 2022 Greater Wellington publicly notified the Summary of Decisions Requested on Proposed Change 1 to the Regional Policy Statement for the Wellington Region (Proposed Change 1) and called for further submissions. Some submitters subsequently made Greater Wellington aware of omissions and errors in the document and an Addendum ('Addendum 1') was notified on 19<sup>th</sup> December 2022. Following the notification of Addendum 1, further errors and omissions were identified by submitters in the Summary of Decisions Requested.

Greater Wellington has corrected the affected submission points, and these are shown in the 'Addendum 2' document. This notification only applies to submission points identified in the Addendum 2 document and all other parts of the Summary of Decisions Requested and Addendum 1 documents remain unchanged.

### Who can make a Further Submission?

A Further Submission may be made by any person who:

- Represents a relevant aspect of the public interest; and
- Has an interest in the proposal that is greater than the interest of the general public.

(an explanation for the reasoning behind why you qualify for either of these categories must also be provided) or,

• The local authority itself.

### How to make a Further Submission:

  - Drop it off at reception at one of Greater Wellington's offices, marked ATT: Hearings Advisor.

Due to delays in postal services and the timeframe for making Further Submissions we highly recommend that an electronic copy of your Further Submission is provided by the closing date.

### Further Submission Form requirements:

- If you require more space than the table in the form provides you can attach additional pages as required.
- All sections of this form need to be completed for the Further Submission to be accepted.

Further Submissions on submission points contained in the Addendum 2 document must be received by 5.00pm Wednesday 25<sup>th</sup> January 2023.



## You must send a copy of your Further Submission to the original submitter

Any person making a Further Submission must serve a copy of that submission on the original submitter no later than five working days after the submission has been provided to Greater Wellington. Each submitter has an address for service available on our <u>website</u>.

If you have made a Further Submission on several original submissions, then copies of your Further Submission will need to be served with each original submitter.
