Pursuant to Clause 8B of Part 1, Schedule 1 and Clause 39 of Part 4, Schedule 1 of the Resource Management Act 1991

Proposed Change 1 to the Regional Policy Statement for the Wellington Region – Hearing Stream Three

Time: 9:30am

Hearing Date: Week Commencing 28th August through to 6th September (actual sitting days will be confirmed once submitter interest to speak has been received 14/8/23)

VENUE UPDATE: Naumi Hotel, 213 Cuba Street, Te Aro, Wellington 6011.

Greater Wellington is now at the stage of Hearings, where Submitters have the opportunity to speak to the Panels about their Submission. We have two Hearing Panels appointed for this Hearing:

- The Part 1, Schedule 1 (P1S1) Hearings Panel, appointed by the Council, who will hear and make recommendations on submissions in relation to the Part 1, Schedule 1 provisions of RPS Change 1
- The Freshwater Hearings Panel (FHP) panel, appointed by the Chief Freshwater Commissioner, who will hear submissions on the Freshwater Planning Instrument component of RPS Change 1.

The Hearings are split up into 7 streams, each covering a specific topic. This Notice relates only to Hearing Stream Three – Climate Change.

Hearing Stream Three (HS3) will commence on Monday 28th August at 9:30am, **at VENUE UPDATED 7 AUGUST 2023** – <u>Naumi Hotel, 213 Cuba Street, Te Aro, Wellington</u> and will cover Climate Change with the following report topics:

- Climate Change General
- Agricultural Emissions
- Energy. Waste and Industry
- Natural Hazards
- Nature-Based Solutions
- Transport

Presenting your Submission

The Hearing Panels will have read all submissions, evidence, and pre-circulated documents prior to the Hearing. Your presentation should focus on the key points of your submission.

The Hearings Panels have advised that submitter presentations should be approximately 10 minutes. Please note that this time **does not** include questioning time from the Hearings Panels, question time will be added to your allocated speaking time.

If you require a longer than 10 minutes for your presentation time, you need to request this when completing the following form by 5pm Monday 14th of August 2023. This request must include a justification as to why extra time is required, and an indication of how much extra time you may require.

Submitters may choose to appear in person and/or by Zoom link. We kindly request that Submitter presentations and speaking notes be supplied via email to <u>regionalplan@gw.govt.nz</u> by 5pm Wednesday 23rd of August 2023. Please note that data provided via USBs will not be able to be accessed due to digital security reasons.
